JOSEPH — For more than 90 years, the Oregon-Idaho Conference of The United Methodist Church has owned the Wallowa Lake Camp just outside of Joseph. The camp encompasses 52 acres, including 1.5 acres of Wallowa river property with the potential to be restored as sockeye salmon spawning habitat. Beginning at 1 p.m. Aug. 1, tribal leaders will join with United Methodist officials to celebrate the return of this 1.5 acres of land to the Nez Perce Tribe by transferring the property deed. The celebration will also include symbolic gestures of return, prayer, music and storytelling.
