Cost of Union school lunches to rise slightly

Union School District students will be paying a dime more for lunches in the upcoming school

The school board voted Wednesday to raise the cost of its lunches by 10 cents. The increase takes effect when classes begin Aug. 27. The new lunch prices will be \$2.35 for students in kindergarten through sixth grade and \$2.60 for students in grades 7-12.

The cost of breakfast will remain \$1 for students in all grades, said Union School District Superintendent Carter Wells.

The lunch price increase was needed to allow the Union School District to continue to align with standards of the federal government's National School Lunch Program. School lunch prices must be maintained at a certain level for a school district to remain eligible for the federal government's free and reduced lunch program, Wells said. Through this program a school district provides free and reduced cost lunches to eligible students from lower income families and are reimbursed fully for them.

Items also discussed at the meet-

ing included the school district's enrollment outlook, which Wells said appears promising based on student registration and other

"We are predicting that enrollment should be up, but we will not know for sure until we see students in the buildings," he said.

The superintendent said if the number of students enrolled this fall is up from last year, it will be the third year in a row the district has had an increase.

Last September, Union's enrollment was up about 30 students from the fall of 2016.

Enrollment is a critical piece of a school district's funding since districts receive at least \$6,000 from the state per student each school year.

Wells said the school district has had to make a number of changes and adaptations as its enrollment has risen, but he is not complaining.

"It is a good problem to have," he

Building upgrades and renovations completed over the summer were also discussed at Wednesday's meeting. The work done includes the addition of new fixtures and paint to the girls locker room in the school district's gym building and a elementary school restroom and the painting of two restrooms in the high school.

Much of this work was funded by a donation from a local family.

"Union is a wonderful community, and this is another example," Wells said.

The district's maintenance staff has also been busy refinishing the bleachers in the gym and the schools' floors this summer.

"I can't say enough about all the great work our staff has done this summer," Wells said.

Firefighters respond to Blue Mountain Seeds

A fire broke out at the Blue Mountain Seeds location Thursday afternoon around 2 p.m.

According to La Grande Rural Fire Chief Larry Wooldridge, the fire originated with a piece of machinery in one of the buildings on Highway 82 near Imbler. The fire then expanded and went into the actual wood part of the building itself, and down into the basement and where it began to burn up into the main structure.

Wooldridge said all the departments in the county sent resources to this fire, but the firefighters still struggled with not having enough manpower.

"Our main challenge was access to the fire because we couldn't get to it with ladders," Wooldridge told The Observer. "The city (La Grande) was having difficulty getting their ladder truck to the fire too."

That, plus the heat of the day and the lack of manpower made for some challenges.

Wooldridge estimated there were 20 to 24 firefighters who responded. He said the firefighters would be sent to get some water and rest periodically then would return as soon as they looked like they were ready to go back in.

"We did a tactical pause twice," Wooldridge said, explaining everyone got together once the fire wasn't free burning to hear the plan of action, drink some water and rest.

The firefighters eventually got the fire under control and started dispersing around 6:30 p.m., he said.

"(La Grande Fire Chief Les) Thomas was there and helped an immense amount," Wooldridge said. "The guys did great. It was a good example of where we had a limited amount of people and everyone stepped up."
