According to the release, it is important for individuals to know if current smoky conditions pose a health risk.

"Smoke from wildfires is a mixture of gases and fine particles from burning trees and other plant materials. Smoke can hurt your eyes, irritate your respiratory system and worsen chronic heart and lung diseases."

People most at risk are those with heart or lung diseases, and older adults and children. Those who suffer from chronic diseases should call their doctor if their condition worsens. LGFD reminds everyone to pay attention to local air quality reports and to limit their exposure to smoke.

Continued from Page 2A those traveling from out of town need lodging and the festival can't oversell tickets due to capacity issues. Though the Granada will remain a central venue, its seating capacity is limited, as is the space in hq, a creative mixed-use space/ music venue downtown that hosts some festival screenings and the after parties. With renovations of another downtown venue, the Liberty Theatre, ongoing, Jennings hopes EOFF will eventually utilize that space to support a bigger boom of attendees in the future.

Jennings said that being backed by the city would provide the additional funding and operational support needed to bolster the festival, but securing the city's investment in the program has so far been a losing battle.

"We've worked hard to garner (the support of) the city, chamber, tourism (and) county over the years and haven't

been able to land that," he said. "We just don't have the civic support that most organizations (like ours) have in their communities."

Jennings plans to meet with the Union County Chamber again soon and is hopeful his efforts won't be in vain.

"We really do need to get a commitment from our civic organizations and our municipalities, the people who are getting taxes specifically to pay for this type of stuff," he said. "We need to start organizing those funds, charge that energy and put it into something that's working, help fund those things that can actually make a big impact and

by doing so create themselves some sustainability."

Current funding for EOFF is mainly based on membership and local sponsors, and the team is planning to host a "Big Lebowski"-themed party/fundraiser at hq Sept. 21. In the meantime, Jennings is curating a "Sneak Peek and Pass Sale," where festival-goers can lock in their tickets, binge watch trailers for the films and be the first to find out who's the "big player" due to appear at this year's fest. (Spoiler: It's not Steven Spielberg).

For Jennings, the crux of the film festival has always, and will continue to be, about
