Mona will run for reelection less than six months after being appointed, against Wes Williams, an attorney based in La Grande.

The opponents are not related. Mona is originally from Joseph, where she graduated from Joseph High School. She then went on to

attend Eastern Oregon Universitv. where she earned a bachelor of science degree in 1986. Three vears later, she earned a juris doctor degree from the University of Idaho. In 2007, she was elected Wallowa County DA.

Mona had previously considered becoming a judge, but it wasn't until West announced his retirement that the circumstances felt right. Additionally, she was planning not to run for reelection as Wallowa County DA, so she readily welcomed the new opportunity.

Boise Cascade to sell La Grande, Island City facilities

Boise Cascade entered into a purchase agreement Tuesday with Woodgrain Millwork to sell three of its facilities in Northeast Oregon.

According to a press release posted to the Nasdaq website, Woodgrain has agreed to take over the Boise Cascade lumber

mills in La Grande and Pilot Rock and the particleboard plant in Island City. This transaction does not include the plywood mill or the powerhouse and log utilization center in Elgin.

"The sale to Woodgrain allows us to further focus on our veneer-based engineered wood products and plywood businesses," said Mike Brown, senior vice

president of operations, Boise Cascade Wood Products division, in the release. "Woodgrain is a family-owned company with a solid reputation in the industry. The products manufactured at these Northeast Oregon facilities are a good fit with their business strategy."

Lisa Chapman, Boise Cascade media contact, told The Observer

on Tuesday the sale will impact 109 employees in Union County. A total of 256 employees, including those in management, work in the three facilities.

The due diligence process, which looks at Boise Cascade's assets and liabilities, will take approximately 50 to 60 days, Chapman said. After that, the

UNION WELCOMES NEW CREDIT UNION

■ Old West Federal Credit Union restores local banking in Union, cuts down on citizen travel

A new financial institution is in Union's future.

Old West Federal Credit Union has purchased the former Community Bank branch building at 539 South Main Street and announced it will open a branch there. An opening date has not been set, but minor

work, site preparation and equipment installation will start in several weeks.

"We are very excited to be bringing banking services back to the folks of Union, and I want to thank the city leaders, past and present, local business owners and Bob Kavanaugh of the Union County Chamber for the role they all played in bringing Old

West to town," said Ken Olson, Old West's CEO and president.

Union has not had a bank in town since Umpqua Bank closed its branch in late June

Olson said there is a chance Old West could open its new branch in Union within the next 3-1/2 months.

"Ideally, we would like to be in before the first of the year," he said.

Olson said the actual schedule will be determined by how long it takes Old West to secure certain types of specialized items, including cash handling equipment and an automatic teller machine.

Old West is a community-chartered, federally insured credit union with more than \$170 million in assets and 12,000 members in and around Eastern Oregon. Credit unions are notfor-profit organizations

Wallowa County Commissioner race attracts a pack

■ Four candidates file in less than two weeks

A flurry of candidates filed to run for Wallowa County Commissioner over the last two weeks following the death of Commissioner- elect Bruce Dunn.

In order to fill the position for the November general election, the county was granted an expedited candidacy filing period by the Oregon Secretary of State just days after Dunn's death.

Dunn won the non-partisan race against Diane Daggett in May and was to be sworn in at the Wallowa County Commissioners' Jan. 7 meeting. He died of a heart attack Aug. 21 while

touring a timber harvest unit associated with the Lower Joseph Creek Restoration Project.

Dunn's former opponent is one of four candidates who filed to run before the Sept. 4 deadline.



The Joseph native said as commissioner she would focus on protecting the constitutional rights of Wallowa County residents.

That's the challenge presenter Doug Crawford issued to an auditorium of almost 300 seventhgraders Tuesday morning on behalf of Protect Young Eyes, a program educating students on the risks associated with internet and social media use and how to use those platforms more responsibly.

Middle schoolers from across Union County gathered at EOU's Gilbert Center Sept. 11 for an afternoon of presentations and three different breakout sessions to discuss topics such as cyberbullying, respecting others online, identifying and cultivating healthy relationships and the risks and laws surrounding sexting.

The potential dangers inherent in social media are a reality for children and teens no matter
