Youth question Oregon gubernatorial candidates

PORTLAND — Young people questioned Oregon's main gubernatorial candidates on topics ranging from foster care to gun restrictions to bullying at the candidates' first debate in Portland Tuesday evening.

Democratic Gov. Kate Brown, Republican Knute Buehler and Patrick Starnes of the Independent Party met at the event dubbed the Debate for our Future.

The candidates sparred most intensely over the topic of education funding specifically related to underrepresented groups such as Native Americans.

Buehler said the single biggest failure of Brown's administration was that not enough money was getting into the classroom because too much of it goes to state and local government employees' pension plans.

Brown said she was proud of a measure that allowed tribal elders to teach native languages in public schools to all students and that by significantly investing in underserved communities, graduation rates have gone

Later, 15-year-old Rose Lawrence from Portland repeatedly asked the candidates what they would do as governor to make schools safe for LGBTQ youth after saying she didn't think the candidates had answered her question.

Brown mentioned among other ideas an anti-bullying policy for safe and secure schools and encouraged students to speak out. Buehler said he'd continue the good work of Brown on the issue and said students should report bullying directly to the

governor's office. Both mentioned hiring more teachers and counselors and those that better reflect a diverse population.

"I would hire you," Starnes told Lawrence to audience applause.

Buehler, a prominent
Republican in the Oregon
Legislature, beat two main
rivals in the GOP gubernatorial primary. Buehler was the
most centrist of the Republi-

can front-runners.

Brown was first appointed governor in February 2015 after John Kitzhaber resigned. She easily was elected in her own right in 2016 to finish out the term of Kitzhaber, who resigned amid accusations of influence peddling involving his fiancee.

The next two debates are scheduled for Oct. 4 in Medford and Oct. 9 in Portland.

Oregon widow sues dead husband's alleged lover for \$1M

PORTLAND — An Oregon widow has filed a \$1 million lawsuit against a woman she believes was having an extramarital affair with her husband.

The Oregonian/Oregon-Live reports the lawsuit was filed Friday in Benton County Circuit Court.

In the suit, Lana Dong claims that the circumstances of the affair between her husband and Anh Tram Gia Phan led to her husband's death

Dong claims in the suit that Phan was negligent for not doing a better job of hiding the affair.

The lawsuit says on Dec. 5, 2017, Phan's ex-husband caught the philandering pair at Phan's Corvallis nail salon.

The suit claims the exhusband beat Mitch Xuan
Dong with a baseball bat and
stabbed him. He died a week

Phan's ex-husband, Than
Duy Kim of Albany, was
charged with murder and
has pleaded not guilty.

Phan declined to comment on the suit.

Woman sentenced to seven years in kidnapping case

SALEM — A Salem, Oregon, woman arrested along with her boyfriend for allegedly kidnapping and attempting to murder a woman has been sentenced to six years and 10 months in prison.

The Statesman Journal reports that Eva Villarreal, 37, pleaded no contest this week to the lesser charges of second-degree kidnapping, second-degree assault and third-degree assault for her role in the attack.

Villarreal and her longtime boyfriend Juan Robert Garza, 39, were arrested on suspicion of driving Garza's childhood friend into the countryside, cutting her, strangling her, hitting her on the head with a flashlight, attempting to tie her up with zip ties and throwing her in a car trunk.

Three killed in Oregon crash

GATES — Three people were killed and another two were seriously injured after the SUV they were traveling in crashed east of Salem.

KOIN reports the crash happened Monday shortly before 7 p.m. near Gates.

According to the preliminary investigation, a silver GMC Envoy carrying the five occupants was traveling west when it left the roadway and hit several trees.

The driver and one passenger were taken to local hospitals with serious injuries.

Two occupants were ejected from the car and pronounced dead at the scene. A third occupant remained in the SUV and also died at the

scene.
The Oregon State Patrol says speed and alcohol are being considered as factors in the crash.

Several injured in collision between bus and minivan

Authorities say a man driving a minivan was seriously injured and some students suffered minor injuries when the minivan collided with a school bus south of Newport

in Waldport.
The Oregonian/
OregonLive reports the crash
happened Tuesday morning when minivan driver
Kenneth J. Hall crossed into
oncoming traffic and hit the
bus head-on, according to
the Lincoln County Sheriff's
Office.

The sheriff's office says Hall of Waldport was flown to a Corvallis hospital for treatment of serious injuries.


The sheriff's office says some of the students on the bus suffered minor injuries.
