Homicide investigation continues in Cove

The homicide investigation continues in Cove, as detectives and deputies for the Union County Sheriff's Office and partnering agencies are making solid progress, according to Sheriff Boyd Rasmussen.

"We are also working closely with the District Attorney's office, and every day our understanding of what happened and who was involved increases," Rasmussen said.

On Nov. 17, Sixty-twoyear-old Loretta Williams called 911 to report a man in her backyard in Cove at approximately 1:40 a.m. The dispatchers heard her confront the man and then heard a loud noise.

Deputies and troopers arrived within minutes and found Williams dead of one or more apparent

gunshot wounds. Rasmussen said when Williams was talking to dispatchers she told them "she might know who it was."

Now, Rasmussen said law enforcement is looking to gather evidence that proves the case "beyond a reasonable doubt"

reasonable doubt."

"We are determined to find justice for Loretta

and her family," he said.
"That means moving
forward carefully to build
that solid foundation and
case for conviction. A great
deal of forensic evidence
has been recovered, which
could prove crucial. Our
crime lab partners have
made its analysis a high
priority, but it does take
time."


