TODAY'S HIGHLIGHT

On June 10, 1967, six days of war in the Mideast involving Israel, Syria, Egypt, Jordan and Iraq ended as Israel and Syria accepted a United Nations-mediated cease-fire.

ON THIS DATE

In 1610, Englishman Lord De La Warr arrived at the Jamestown settlement to take charge of the Virginia Colony.

In 1692, the first execution resulting from the Salem witch trials in Massachusetts took place as Bridget Bishop was hanged.

In 1935, Alcoholics Anonymous was founded in Akron, Ohio, by Dr. Robert Holbrook Smith and William Griffith Wilson.

In 1942, during World War II, German forces massacred 173 male residents of Lidice, Czechoslovakia, in retaliation for the killing of Nazi official Reinhard Heydrich.

In 1944, German forces massacred 642 residents of the French village of Oradour-sur-Glane.

In 1957, in Canadian elections, John Diefenbaker led the Progressive Conservatives to an upset victory over the Liberal party of Prime Minister Louis St. Laurent.

In 1971, President Richard M. Nixon lifted a two-decades-old trade embargo on China.

In 1977, James Earl Ray, the convicted assassin of civil rights leader Martin Luther King Jr., escaped from Brushy Mountain State Prison in Tennessee with six others; he was recaptured June 13.

In 1978, Affirmed, ridden by Steve Cauthen, won the 110th Belmont Stakes to claim horse racing's 11th Triple Crown.

In 1990, Alberto Fujimori was elected president of Peru by a narrow margin over novelist Mario Vargas Llosa. Two members of the rap group 2 Live Crew were arrested in Hollywood, Florida (they and a third band member were later acquitted of obscenity charges).

Missing 11-year-old OK after overnight search in Anthony Lakes area

Searchers found a 11-year-old boy, Helaman Garcia, in good health early Sunday morning after an overnight search for him that began about 6 p.m. Saturday in the Anthony Lakes area of the Elkhorn Mountains about 30 miles northwest of Baker City.

Baker County Dispatch received a report of lost hikers at 5:55 p.m. Saturday, a Sheriff's Office press release stated. Search teams found the boy about

3:50 a.m. Sunday.

Temperatures in the area dipped into the 20s during the night.

Garcia had gone on a day hike with a group that included his aunt and uncle, who live in La Grande, and three other juveniles. Names of the other hikers were not available by press time. The group became separated on a trail near Van Patten Lake. The adults and three juveniles were able to hike out, but the 11-year-old boy became separated from the group.

He was wearing shorts and a light jacket during his overnight stay in the mountains.

The Sheriff's Search and Rescue Team was activated along with officers from the Sheriff's Department and Oregon State Police, the press release stated.

Grant County Search and Rescue sent multiple teams, including a K-9 team to help with the search. North Powder Fire and Rescue sent volunteers and Life Flight and Oregon State Police sent aircraft

in the hope of sighting the boy from the air, the press release stated.

After the boy was found, he was evaluated and determined to be in good health. Search teams waited until daylight to hike back out and the boy was reunited with his family.

The Sheriff's Office expressed appreciation to the staff at Anthony Lakes, who opened the lodge for the boy's family and friends and the Search and Rescue Team.

Two cases of measles in Idaho pan-handle

MOSCOW, Idaho — Authorities have confirmed a second case of measles in the Idaho panhandle.

The Moscow-Pullman Daily News reported that the patient in Latah County is a family member of a young child who was confirmed as the first case last week.

The child had had one measles vaccine but had not had the second dose due to age.

Both are believed to have been exposed during international travel.

The cases are the first instances of measles in Idaho since 2001.

Authorities say that anyone who was at the Trinity Reformed Church in Moscow, Idaho on May 26 between 9:15 a.m. and 2 p.m. or at Gritman Medical Center between 11 a.m. and 2:30 p.m. on May 31 in the laboratory and diagnostic imaging departments could have been exposed to the virus.

Baker to consider ordinance billing non-residents for equipment use in accident

Baker City might start sending bills to people who live outside the city limits and who don't pay city property taxes when they're in a car accident that requires the fire department to send equipment other than an ambulance.

The City Council will consider a proposed ordinance setting the fees when it meets Tuesday at 7 p.m. at City Hall.

The city already bills both residents and nonresidents for ambulance runs.

But in the case of, for instance, a traffic crash on Interstate 84 that requires a fire engine as well as an ambulance, the city doesn't include the

cost of sending the engine in the bill.

But unlike city residents and property owners, who help support the fire department with property taxes, nonresidents who don't own property within the city limits don't pay the tax, which is a major source of revenue for the department.

According to a report that Jeanie Dexter, the city's finance director, wrote for councilors, the ordinance would allow the city to bill nonresidents for fire services "relating to motor vehicle accidents and/or motor vehicle fires (including, but not limited to, vehicle extrication, vehicle fire services and accident scene management) to more nearly equalize payments of users for

operation and maintenance of the fire and emergency services system."

The ordinance would not be limited to vehicle crashes and fires.

The city could also bill nonresidents when fire crews respond to "unauthorized open burning" and incidents involving hazardous materials.

The proposed fee schedule includes rates of \$250 per hour, plus actual labor costs for personnel involved, for incidents in which a fire engine or ladder truck responds.

The cost for an ambulance that is on standby would be \$125 per hour plus labor costs. The proposed fees are based on averages from the International Fire Chiefs Association.

Portland police shoot man with knife in downtown building

PORTLAND — Officers shot and killed Sunday a man armed with a knife who suggested he had an explosive device, the Portland Police Bureau said.

The incident happened shortly before 10 a.m. at a building in downtown's Pearl District, police said. Officers were called to the building in response to reports of a disturbance caused by a man with a knife.

When officers arrived, they saw a man and a woman in the stairwell of the building, police said. The woman appeared to be injured.

Officers tried to talk with the man and used less lethal force before the shots were fired, police said. The man died at the scene, said police, who did not release the man's age or identity.

The woman was taken to the hospital for treatment of her injuries. No officers were injured, police said.

The bureau's Explosive Disposal Unit determined there was not an explosive

at the scene.

Mike Connors, a lawyer who works in the building, told Oregonlive/The Oregonian that he was arriving at work Sunday morning when he heard people arguing in a stairwell. Connors said he called 911 and yelled into the stairwell that he had done so.

He said he heard a man's voice shout back, "I have a knife, a bomb and a hostage. Bring it on."

Connors told the newspaper that he left to wait for police to arrive and didn't witness the subsequent shooting. "I was kind of in shock," he said.

Portland Police Homicide Detectives and the Multnomah County District Attorney's Office are investigating.

Pilot, passenger injured in Oregon small airplane crash

MEDFORD — Authorities say the pilot and a passenger were injured when a small plane crashed in an Oregon neighborhood following mechanical problems.

The Medford Mail Tribune reported the men

aboard the private plane sustained minor injuries just before 2 p.m. Saturday when Medford police say the aircraft crashed into a tree in the yard of a Whittle Avenue home.

A police release says

the plane had just taken off from Rogue Valley International Airport in Medford.

The Mail Tribune said witnesses saw the pilot and the passenger bloodied but walking before they were

taken by ambulance to a nearby hospital. Their identities haven't been released.

Police say no one on the ground was injured. The release identifies the plane as a single-engine 1947 Beechcraft Bonanza.
