

Art at the Crossroads

BAKER CITY — The 22nd-annual Art at the Crossroads open regional show opens Sept. 4. Artwork will be accepted on Tuesday, Sept. 1, at the art center, 2020 Auburn Ave.

Monetary prizes and awards will be presented at the judge's discretion. A People's Choice award will be selected by the community and patrons who attend the opening reception and cast their vote before 8 p.m.

The show is open to professional and amateur artists aged 18 and older. Each artist may submit a total of three works of art that have not previously been shown at a Crossroads Open Show.

The entry fee is \$20 for Crossroads members or \$25 for nonmembers.

All items must be available for sale. This will be the standard procedure for all open shows in the

future. There is a 30% commission for Crossroads member artists and a 40% commission for nonmembers.

Paintings must be dry and appropriately presented, mounted or framed, ready to hang with D-rings and wire attached. No saw tooth hangers will be accepted.

Work submitted must be of original design, of high quality and to the best of artists' knowledge not violate any copyright laws. If artwork is over 50 pounds or more than 40"x40", please make arrangements with gallery two weeks prior to intake day. Please contact crystal@crossroads-arts.org to make arrangements.

Work must be delivered upon specified intake day with entry fee and completed Exhibit Contract.

Volunteer Requirements Include:

- At least 21 years old
- Be willing to complete necessary background checks, provide references and participate in an interview.
- Complete a minimum of 30 hours of pre-service training.
- Attend all court proceedings
- Be willing to commit to the CASA program for at least two years.
- Have 5-15 hours per month of time to give while working your case

CASA VOLUNTEER TRAINING

Responsibilities of a CASA



Establish relationship with child and others involved



Meet with the child regularly (at least 2 times a month)



Submit required reports and case updates



Attend ALL court proceedings & monitor court orders to ensure compliance



Complete 12 hours of in-service training yearly



Assess the child's physical, mental, behavioral, & educational needs. Advocate for services



Observe parent/child interactions



Maintain documentation required by CASA staff



Maintain contact with Case Manager
