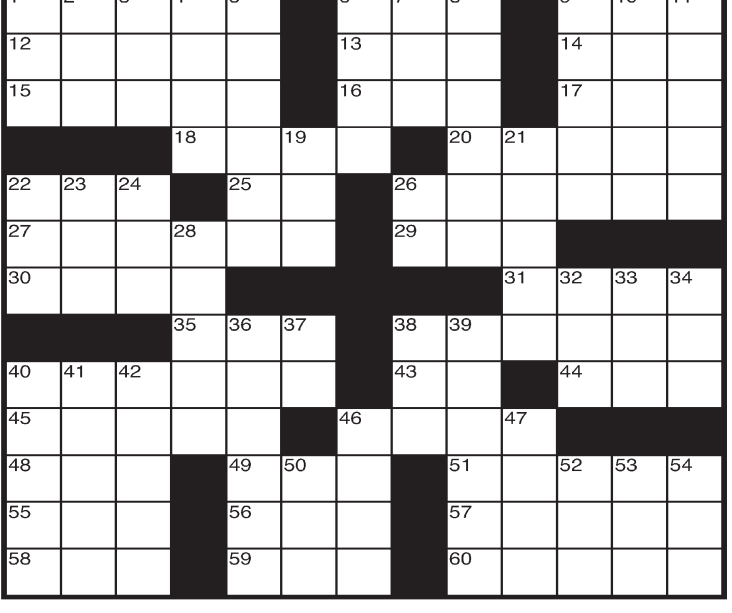
CROSSWORD PUZZLER
