Amendment Summary: The City of La Grande is proposing to adopt a new/updated Parks Master Plan, which will be incorporated into the La Grande Comprehensive Plan Ordinance 3208, Series 2013, Planning Goal 8 - Recreation.

The review criteria for considering a Comprehensive Plan Amendment is found in the City's Land Development Code Ordinance 3252, Series 2021, Article 8.7. The City of La Grande City Council will subsequently hold a Public Hearing on June 1st, 2022, at 6:00 p.m. in the City Hall Council Chambers at 1000 Adams Avenue, La Grande, Oregon. The proposed ordinance adopting the Parks Master Plan will be read for the first time by title only.
