

Agriculture must vote!

By now, Oregonians should have received their ballots in the mail for the November election. If you work in a job related to Oregon agriculture or natural resources, and you haven't voted yet, please take the time to do so.

"It's imperative that Oregonians working in agriculture, forestry, fishing, and natural resources vote on Election Day to carry our priorities forward," said **Jonathan Sandau** of Oregon Farm Bureau's (OFB) government affairs team.

To help farmers and ranchers determine which measures and candidates are best for ag, OFB offers our 2018 Election Guide at **OregonFB.org/election**.

OFB-endorsed incumbents were evaluated on their voting records on Farm Bureau priority bills during the 2017 and 2018 Oregon Legislative Sessions. Newcomers were chosen based on interviews with OFB grassroots leadership, along with input from County Farm Bureaus and OFB staff.

The ultimate aim is to support lawmakers and measures that most

reflect OFB's policy positions, which are developed and updated through an annual grassroots democratic process involving voting members of Farm Bureau. (See the full OFB Policy Book at OregonFB.org.)

"The 2019 session will have its threats and opportunities for Oregon family farmers and ranchers. We anticipate legislation on carbon pricing, additional labor costs, water quality, ag production, diesel regulation, and property tax reform, among others," said Sandau.

"It's critical that Farm Bureau members have strong allies who value agriculture and will reliably stand up for farmers, ranchers, foresters, and our rural communities," he said.

Help pass Measure 104 to end easy tax hikes.

Measure 104 will close a loophole that allows

the government to raise revenue on hardworking Oregonians with a simple majority vote — instead of a 3/5 super-majority vote, which was approved by Oregon voters over 20 years ago.

This constitutional amendment would strengthen the 3/5 vote requirement for any revenue increases, including fees, taxes, and the elimination of deductions or tax exemptions.

Help pass Measure 103 to keep groceries affordable.

Measure 103 would prevent the state from raising revenue off the backs of Oregonians by prohibiting taxes on the sale or distribution of groceries, including food production and processing. Food should be kept affordable for all Oregonians.

Apply for Farm Bureau Fire Relief Funds by Nov. 1

Through the generous contributions of **Northwest Farm Credit Services** and individual Farm Bureau member families, OFB established a fire relief fund to support farm and ranch families impacted by the wildfires in Wasco and Sherman Counties this year. So far, the fund has raised over \$27,000. applications for aid. The task force chair is **Ken Polehn**, Wasco County Farm Bureau president and The Dalles-area fruit grower.

The current intent is to provide approximately \$2,000–\$2,500 amounts of help to those who demonstrate uncovered losses (meaning losses not covered by insurance, or other public or private relief funds). Once requests for funds are received and evaluated, this range may be adjusted.

Any Wasco or Sherman County resident who makes a substantial amount of their livelihood from agriculture, and whose agricultural operation suffered uncompensated loss from the 2018 fires, may apply. You do not have to be a Farm Bureau member to apply or receive funds. to Nov. 1, 2018, will be considered.

The task force intends to make funding decisions and distribute monies by Thanksgiving.
