Know who you are dealing with - independently confirm your buyer's name, street address, and telephone number. Never accept a check for more than your selling price.

Resist pressure to "act now." If the buver's offer is good now, it should be good when the check clears. method of payment, such as an escrow service or online payment service. If the buver wants to use a service you have not heard of, be sure to check it out to be sure it is reliable. If you do not feel comfortable with the service, do not
