#### Cheap Freight Rates.

The Southern Pacific railroad company has made a freight rate between Southern Oregon points and San Francisco which is just a shade lower than D H Miller vs J W Hockersmith; between the same points and Portland. This, however, is true only in less than carloads, but on carloads the rate has also been reduced which makes the rate but a few cents per hundred higher. The reduced rates apply from San Francisco only, and does not apply to acids, explosives, fresh fruits, fresh meats, live poultry, and green vege-


