## CAN'T CROWD US OUT

Trade of United States with Canada Shows Big Increase.

This Despite the Fact of the Preferential Tariff Bates Established Brtween Canada and Great Britalu-A Year's Record.


The Canadian preferential tariff in favor of the United Kingdom has not had the expected effect of reducing the proportion which the United States supplies of manufactures imported into Canadian territory. A copy of the Canadian Manufacturer, just received by the treasury department bureau of statistics, sharply calls attention to the fact that imports of dutiable arti-cles into Canada from the United States in the fiscal year 1899 aggre-gated over \$44,000.000 and from Great Britain less than \$28,000.000, and that the United States is furnishing a much larger amount of manufactures of iron and steel than the United Kingdom, and adds:

"The preponderance of trade is overwhelmingly in favor of American man-ufactures, and tariff preference in favor of British goods to the contrary notwithstanding, American manufac tures are taking the cream of the bush-pess. Is it possible that British mannfacturers are entirely unable to com-pete in the Caradian market?"

The Canadian tarlif, it will be re-membered, was in 1897 to adjusted that the duty on articles entering Canada from the United Kingdom was made, beginning with April, 1897, 12% per cent. less than the rate from other parts of the world, and on July 1, 1898. cont, loss than the rate from other parts of the world, and on July 1, 1898, another admetion in favor of the Unit-ed Kingdom way made, bringing the lotal reduction to 20 percent of the Unit-ing hurried along. to a light reduction to 25 per cont. as against goods coming from other parts of the world. A recent announce-ment indicates that, beginning with July 1, 1993, a still forther reduction would be made, so that the rates of duty on articles from the United Kingdom would be 32 1-3 per cent, less than those from other parts of the world. While the effect of the third reduction of 12½ per cent., which went into oper-ation July 1, 1900, cannot yet be determined, it is practicable to compare the imports of manufactures into Canada from the United Kingdom and the United States respectively during the United States respectively during the years ending June 30, 1898, 1899 and 1900, and thus determine whether the advantages which the manufacturers of the United Kingdom during that time have a perceptible effect upon the relative growth of the imports of Cana-ch from the two countries, the United Kingdom and the United States.




