"MONEY is fast going into ship building and for the simple reason that it is a good investment of capital. Only twice in the history of this country has the output of the shipyards of the United States exceeded that of the fiscal year which closed with June. The highest mark reached in this country in ship building was in the year 1855 in that year the gross registered tonnage of the shipyards was 533,450 tons. The fiscal year just closed was 401,285, which was about 100,000 tons gain over the preceding year. The large increase in the output of the ship yards is fast displacing any material need of public assistance in the matter by way of subsidies or bounties.—Albany Herald.

THE possibility of Mr. Bryan being a Socialist candidate for president has not been thought of—not even by Mr. Bryan himself. One of the socialist conditions is equality as regards money and property possessions. Mr. Bryan's \$150,000, we presume, would not willingly, even with a shadow of presidential possibilities, be shared with anyone. The story of Mr. Bryan and his wealth is told below by President J. B. Wright, of the Columbia National Bank, of Lincoln, Neb., who was in Kansas City the other day: "The Bryan of yesterday was a presidential possibility, and all its attendant characteristics. He was a hail fellow well met with everybody. Today it is another story. He is becoming reserved, and is assuming the general air of the money maker. Years ago when I first knew Mr. Bryan he was an obscure attorney in an obscure town. Twelve hundred dollars a year was wealth to him then. Today Bryan is worth \$150,000 and is rapidly adding to the pile. He made \$50,000 last year lecturing and with his pen, which is itself a White House salary. He is having plans drawn for a rather pretentious mansion on his farm a few miles out from Lincoln."

Willoughby Arrested for Forgery.

On Friday of last week Constable T. W. Johnson left Medford for Coquille City, Oregon, with a warrant in his pocket for the arrest of G. H. Willoughby, who had been located at that place. The warrant was sworn out by J. E. Enyart, cashier of the Medford bank, and charged Willoughby with forgery. Upon information being received by Mr. Enyart, who has been tracking Willoughby for nearly two years, that he was at the above named place he at once swore out a warrant and the officers there were notified to arrest and hold him until an officer from Jackson County could reach there. The arrest was made according to instructions, despite the fact that Willoughby insisted that he had never been in Jackson County. Upon the arrival of Constable Johnson in Coquille the identity of the prisoner was established beyond the question of a doubt and he was taken in charge by the constable and the trip to Medford was at once commenced, arriving here on Wednesday of this week. There are few Medford or Jackson County people who do not remember Willoughby, who was selling school supplies to the school directors of the different districts of the county a couple of years ago. He did a good business in his line, in fact he did too much business, and trouble he piled up then for himself is now, like the feathered biped, coming home to roost. He was in the habit of selling school supplies to the directors and taking in pay school warrants issued by these directors. These warrants he would afterwards sell to banks or men of means who were looking for money investments. He is now under arrest, charged with forging the names of school clerks and directors to some of these warrants, which, after the signatures had been forged, were sold to various parties in this locality, among them being the Medford bank and G. H. Haskins. The aggregate amount of the forgeries was something over \$200.

The forgeries were committed in September, 1899. Willoughby left here about holiday time following and since then has occupied various positions in Coos County. He was bartender in Empire City for thirteen months and at the time of his arrest was training race horses on the track at Coquille City. He is said to have conducted himself as an honest, square way while in that locality, and Constable Johnson says he seemingly made many friends among men of means, who, after the arrest, expressed a willingness to render any assistance which might be necessary. However, the charges preferred against him are of a serious nature and it is not improbable that a penalty not small in magnitude will needs be paid before the laws of the state are satisfied. The prisoner was brought before Judge James Stewart Thursday at 11 o'clock for preliminary examination. He waived examination and bonds for his appearance at the September term of circuit court were placed at \$2000, which he had not secured at the time our paper is put to press. He has hopes of securing bondmen in Coquille and Empire but it was not expected the amount would be placed at more than \$500. If bonds are not secured he will be held by Sheriff Orme until court meets.

Death of John F. Gaine.

John F. Gaine, of this city, died at the home of Mr. and Mrs. F. P. Smith, near Ashland, on Saturday, July 13, 1901. Deceased has been ill with consumption for very nearly a year, but during the last few months he had been taking a medicine that was seemingly doing much good and his condition was very much improved, so much so that he was able to be about the streets and on July 23 went to Ashland for a few weeks' visit with Mr. Smith's people. He seemed to improve in health until the night of July 12th, when he was attacked with Bright's disease and from the effects of which he died less than twenty-four hours later, in great agony. Every attention possible was given him, but to no avail, his constitution having been so worn out by his long illness that it was unable to withstand the last severe attack.

The remains were brought to Medford Saturday evening and funeral services were held at the Christian Church Monday afternoon, Rev. Tont, of Ashland, officiating. Deceased was nearly twenty-five years of age and was held in high esteem by everyone who knew him. He was a model young man socially, and in a business way was achieving much distinction for his thorough, accurate and honest methods. He was engaged to be married to Miss Estella Smith of Ashland, the engagement dating back to a few months prior to the beginning of his illness, and in all probability the wedding ceremony would have been celebrated before this date but for his illness which was destined to prevent for all time a union of these two young hearts. Deceased leaves a mother and brother in this city to mourn his untimely demise.

Going After Railroad Taxes.

The following is taken from a published report of the proceedings of the commissioners' court in Douglas County: "J. B. Watson and A. M. Crawford appeared before the board with a proposal in regard to the assessment of the O. & C. R. Co.'s roadbed. They submitted an agreement which after examination was endorsed and signed by the court. They agree to handle the legal work in the district and supreme courts, on behalf of the county, in establishing an increased assessment valuation on said roadbed—\$10,000 per mile if possible—which they claim the earnings of the road will justify—and their compensation, if any, is to be one-half of the additional taxes received for the first year after such increase, if any, is secured."

Mr. Watson was one of the attorneys in the suit which Jackson County brought against the railroad a few years ago.

Horses Drop Dead from Heat.

Mr. W. E. Hurd, of Portland, who has but recently returned from the east, tells the Telegram of the heat in New York City, in the following paragraph: "People here (in Portland) have no idea what this heat is and don't know how well off they are in Oregon. I saw nine horses drop dead on the streets of New York within a distance of three blocks. There was no escape from the heat. At Manhattan Beach, even, the thermometer registered 92 in the shade and no less than 100 people are supposed to have succumbed to the heat there in a single day. There were as many people on the trolley cars at 3 and 4 o'clock in the morning as in the middle of the day. In this way they obtained some sleep, as the motion of the car created a breeze and enabled them to get a full breath of air once in a while. Some rode back and forth all night, as the only means of escaping from the insufferable heat. It was no unusual sight to see people roll about in the lawns and in the parks in their effort to obtain sleep at night. Extra police had to be pressed into service to guard the outdoor sleepers. The press dispatches give one but a meager conception of the horrible realities of a hot wave."

Coyote Scalp Swindle.

Twenty-five coyote scalps were presented to the county clerk Wednesday evening by a young man, but on account of uncertainty as to whether they were killed in this county, Mr. Hammer refused to pay for them until evidence was produced on the subject. The stranger left the office and did not come back. The county clerks of the adjoining counties were notified. Several counties have recently paid out quite a sum for scalps and it is thought that a systematic effort is being made to swindle the Oregon counties, the scalps being shipped in from other states. The young man sold his scalps at Eugene, but was immediately arrested and Deputy Clerk Montague went to Eugene to identify him. Benton County bought a job lot of 22 at \$2 apiece a few weeks ago, and other neighboring counties have been taken in likewise. A little vigilance on the parts of the clerks will lessen the dangers of the counties being swindled.

Used Lime Instead of Vitriol.

A gentleman who was in the neighborhood of Junction City relates that his attention was attracted by the fine appearance of a thirty-acre field of wheat. It was beyond doubt the finest grain he had seen this year and he inquired into the cause of its flourishing condition. He was informed that the farmer had experimented with lime, using it in place of vitriol in order to insure his crop against smut. He used the lime liberally, knowing that his land needed lime anyway, provided that the effect on the grain was not all that he hoped for. At the same time he used vitriol on an adjoining field and there was a marked difference. It is stated that lime is much cheaper than vitriol and serves the double purpose of insuring grain against smut as well as enriching the soil.

Oregon Fruit at Buffalo Exposition.

A correspondent of the Fruit Trade Journal of New York City, recently wrote as follows of Oregon's strawberries and apples at the Pan-American Exposition: "Far away Oregon is not to be outdone in having strawberries on exhibition and a card with the following inscription is noticed: 'All the way from Oregon, 3,500 miles without ice.' So, even should our local berry crop be a failure in the future, our millionaires will have Oregon berries to fall back on. It is not to be wondered at that visitors cannot overcome the desire to purloin a sample of the beautiful apples shown by Oregon, and the management of the booth have placed this placard, 'Yield not to temptation.' The Oregon commissioner should have been present years ago and handed this card to Adam."

Hood River Strawberries.

The Hood River strawberry crop this year was a good one. There were 40,000 crates of berries marketed. Last year there were 28,000 crates.

"It is safe to estimate," says the Glacier, "that this year's crop has netted the Hood River farmers \$75,000 in hard cash, and there is hardly an acre in the valley planted to strawberries that has not netted the owner from \$100 to \$400. A few of the farmers with patches along the river bottom favorable to the early ripening of the berries secured fancy prices at the opening of the season, which netted big profits, but a conservative estimate of the average returns for the valley would give the farmers a net profit of \$150 per acre for their strawberry crop. The shipping union will return to the growers an average of \$1.90 per crate."

"The strawberry that has made Hood River famous and is making our fruit growers rich, is the Clark's Seedling.
