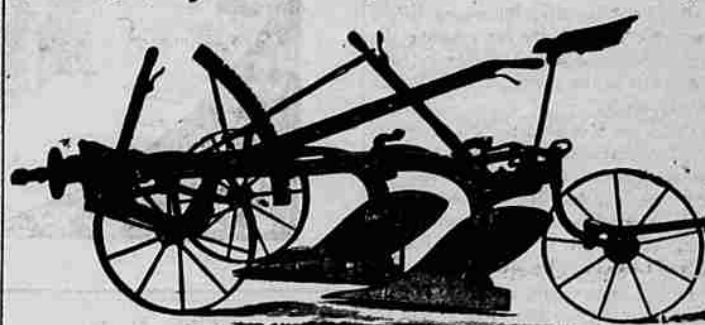

Gave Exhibition Shots.

Captain George E. Bartlett, a representative of the King Powder Company and the Peters Cartridge Company, was in Medford last Saturday advertising his line of goods and while here gave an exhibition of fancy shooting. He used a 22 rifle and the manner in which he would scatter small objects thrown into the air was not slow—and do it in all manner of positions. The captain is truly a marvel in his line. After showing the efficiency of his powder and cartridges he placed an agency with H. G. Nicholson, the hardware man.

Captain Bartlett has a history that stamps him above the average man. It is stated that he won great distinction as captain of the police Indian scouts at Pine Ridge agency, S. D., in 1890 and 1891, and was present at the "Wounded Knee" fight on Dec. 29, 1890, when 400 Indians and 40 United States soldiers were killed. He also was sent out in command of the relief party, who went out to the battle ground on January 1, 1891, to pick up the few wounded Indians that had been left there to die, and with his own hands unfolded a dead mother's frozen arms that encircled a baby girl that was still alive and unharmed. The little Indian girl was afterwards named Lost Bird ("Kilkalan Nuni") and was adopted by Mrs. General Colby, who is now educating her in Washington, D. C., where she is admired by all who know her, for she is quite pretty and very bright—as well as a rare relic of a ghastly murderous fight, and the Ghost Dance war with the Sioux.

A supposed mock marriage between Miss Mary B. Carroll and Joseph R. Hoffmann has resulted in a serious predicament for those two popular young society folks of the west end of St. Louis. The bride is generally considered the prettiest girl in Cabanne. The wedding ceremony was performed in one of the parlors of the Cabanne club by Judge W. W. Henderson, of the probate court, in the presence of a number of friends of the contracting parties.

The ceremony was exactly the same in every detail as that set forth by the statutes of Missouri. The judge asked the usual questions in regular order and the couple gave responses. The only thing lacking was a marriage license, but authorities on marriage laws, among whom are several circuit judges, declare that a license is not necessary and that a marriage ceremony such as occurred in this instance is strictly legal in every sense of the word and binding on both parties. In order to straighten out the legal tangle a separation by law may be necessary.

IN THE PHILIPPINES.

Hon. Luke E. Wright, senior member of the Philippine commission after Governor Taft, has been appointed by President Roosevelt vice-governor of the islands.

Fourteen warships are maintaining a strict blockade of the island of Samar, but in spite of this fact supplies still reach the insurgents. Most of this work is done during dark nights by small boats from the island of Leyte.

Lieutenant William C. Harlee, United States Marine Corps, on a wharf in Manila recently, directed a Filipino boy to take up and carry his gripsack. The boy could not speak English, so did not understand the order, and moved off. The lieutenant thought this insolent and proceeded to thrash the boy with his walking-stick. For this he was tried by court martial, found guilty and suspended from duty for three months, with loss of half pay, and is to be publicly reprimanded.

Twelve men of Company G, Ninth Infantry, under command of Sergeant Wilford, who had been sent from Basy, to San Antonio, island of Samar, to investigate and report in regard to the number of boomen in the vicinity, were attacked by 140 insurgents, who killed two of the soldiers and wounded two others. Wilford remained cool during the attack and the survivors praise his conduct. Captain Bookmiller of Company G recommends Wilford for a medal of honor, and Privates Swanton and Vero for certificates of merit.

Brigadier-General Hughes sent the following to General Chaffee: "The insurrectionary forces in Cebu island have taken the oath of allegiance in good faith. Sixty officers and 400 men have surrendered arms." General Chaffee says "this settles, for the present at least, the disturbance heretofore existing in Cebu."

At Amsterdam, N. Y., Frederick Bankert, at 2 o'clock in the morning, killed William Green by shooting him in the neck with a revolver and splitting his head open with a hatchet. Bankert also shot Mrs. Green and cut her head open with the hatchet, inflicting fatal wounds, and then shot himself through the heart, dying instantly. He was a suitor of Mrs. Green before her marriage, but his love was unrequited.
