OUTLAW TRACY HAS SUICIDED.

Hard Pressed by the Posses and After Being Wounded in the Leg He Ends the Chase by Shooting Himself.

Spokane, Aug. 6.—Harry Tracy, the notorious Oregon outlaw, killed himself in a wheatfield near Fellows, at 4:30 a. m. today, where he had been surrounded. In a fight with a posse of citizens last night, Tracy was wounded in the right leg, between the knee and the thigh, and twenty minutes later, knowing that his capture was certain, he killed himself with a revolver. The body of the outlaw was found in a wheatfield this morning.

Harry Tracy escaped from the Oregon State Penitentiary at Salem, June 9th last, in company with David Merrill, after killing three guards—Frank W. Ferrell, G. R. T. Jones and B. F. Tiffany—and wounding Frank Ingraham, a convict, who tried to prevent his flight. On June 28th Tracy killed Merrill, near Napavine, Wash., shooting him from behind and leaving his body in the forest, where it was found on July 15th. On July 3rd, near Seattle, in a fight with a posse, Tracy shot and killed Charles Raymond, a deputy sheriff; E. E. Breese, a policeman, and mortally wounded Neil Rawley, who died the following day.

Tracy committed many feats of daring during his flight, in the course of which he eluded various posses when apparently surrounded, and held up numerous farmers, whom he forced to furnish him with food and clothing, and by threats of murdering their families compelled them to cover up his tracks. Perhaps his greatest show of daring was displayed on July 2nd, at South Bay, near Olympia, when he held up six men and forced four, including Captain Clark, of the gasoline launch N. & S., to embark with him on Puget Sound and pilot him up-stream for ten hours.

In 1897 Tracy murdered Valentine Hoge, a Colorado cattleman, and William Strong, a boy, in the same state.

TRACY FATALLY WOUNDED BEFORE HE SHOT HIMSELF.

Spokane, Aug. 6.—Upon examination of Tracy's body, it was found that the wound which resulted in the outlaw's death was inflicted by a 45-caliber revolver, held close to his forehead. The top of his head was badly mangled. Two bullet wounds on the left leg showed the cause of the man's despondency. One shot had broken the leg between the ankle and knee. The other cut the tibial artery, which of itself was sufficient cause for death. It is believed that both of these shots were received after the convict left the shelter of the rock and made his break for the wheatfield. The murderer had taken a strap and buckled it tightly around his leg in an attempt to stop the bleeding. Despite the tightly fastened strap, the bleeding continued until he, probably realizing his hopeless condition, ended the struggle.

was asked if the men were entitled to the reward.

"Yes," he promptly answered. "The posse surrounding him was the cause of his committing suicide to save himself from hanging, and the possemen are as much to be credited with his death and rewarded for it as though they had killed him directly."

Doings of the Recorder's Court.

Recorder Snell's court has been working over time for the past week or ten days.

Wm. Bramlet was arrested on July 26th for using abusive and profane language in a house. He was fined \$30 and after boarding out part of the fine paid \$8 and was commanded to go hence. The complaining witness was Susie Veach.

On July 31st Gabe Plymale and Hattie Plymale, his wife, and Wm. Gainey were arrested charged with keeping and maintaining a bawdy house. They were found guilty and Gabe Plymale was sentenced to pay a fine of \$100 and Gainey a fine of \$50, in default of the payment of which they are both now in the city bastille. The woman was allowed to go on her own recognizance—and she has gone, presumably for good.

John Brean was arrested for being drunk and disorderly, was fined \$10 and permitted to go on his own recognizance to secure the necessary fine—and he has not yet returned.

Fay Anderson was brought before the recorder yesterday charged with using obscene language on the street. His trial was on when we went to press.
