NOTED BANDIT ENDS HIS LIFE

RENOUNCES HIS MAKER AND
BIDS FAREWELL TO THE
GIRL HE LOVED.

St. Paul, Oct. 20.—Declaring in his last mad moments that there is no God, and inveighing against the terms of the parole which prevented him from marrying the girl he loved, James Younger, one of the notorious brothers, killed himself with a pistol yesterday.

The Youngers were given the freedom of the State of Minnesota on July 30, 1901, after serving twenty-five years in the Stillwater penitentiary. By the terms of the parole the men were compelled to hold themselves at the direction of the pardon board. Cole Younger became agent for a tombstone concern and Jim worked in a cigar store.

A year ago it was announced that James Younger was to marry Miss Ellen, a young newspaper woman who had interested herself in his case while he was a convict. The board of pardons declined to consent to the marriage, and James became morose. He left his work three weeks ago and took a room in a cheap hotel. Last night he talked and acted queerly, and in the afternoon he was found dead with a bullet hole in his right temple.

Beside the dead man was an open Bible, a dime and a number of envelopes. He had spent his last night on earth writing and left a note written in a scrawling school boy hand and couched in incoherent language, in which he denounced God and the government, and declared himself a Socialist. It is dated "Last Night on Earth," and says in conclusion:

"I have pity for the pardoning board. They don't stop to consider their lives or think of the man that knows how to live and appreciate a friend in truth. Good-bye, lassie."

Cole Younger is ill and declines to talk of his brother. James Younger was the younger of three brothers, Robert, Coleman and James, who, between the years 1896 and 1873, gained great notoriety through their association with Jesse and Frank James. The scenes of most of their alleged post-Redemption depredations was the state of Missouri and those adjacent thereto. In September, 1876, the band entered Minnesota, traversing the state as far as the little town of Newfield, in Rice county, where an attempt was made to loot the First National bank.

FOREIGN FLASHES

Canada's Premier is ill.
Quebec—Although Sir Walter Laurier since his return to Canada has steadfastly denied that he is ill, some of those who have seen him are convinced that he is in delicate health.

Pope in Excellent Health.
Rome—Despite reports to the contrary the pope is in excellent health, considering his great age, and he takes air daily in the gardens, and despite the apparent fragility of his body and mind he is active and alert.

Princess Sophie Gives Birth to a Boy.
Berlin—There is a little royal tumult in a teapot just now over the birth of a boy to Princess Sophie of Hohenzollern, the Morgantie wife of Austria. This is the second child of the archduke, the first, a girl, having been born in 1901.

To Fight for Eight Hours.
Paris—According to the "Patrie," the General Confederation of Labor is considering the question of the strike of all the trades unions of France for an eight-hour work day, old pensions, etc., as demanded by the striking miners. A manifesto to the various unions is said to have been drafted.

Oil King to Visit Cannes.
Cannes—A number of J. D. Rockefeller's servants have arrived here with carriages, horses and automobiles as well as 150 trunks. It is reported that Rockefeller intends to spend the winter here recovering his health. The inhabitants are greatly excited over the coming of the Croesus.

British Yachtsman Pleased.
Glasgow—The nominal acceptance of Sir Thomas Lipton's challenge pleases the British yachtsmen. The sportsmanlike attitude of the New York Yacht club in accepting the conditions of 1901 for a challenge despite the deed is greatly commended. It is the belief that no serious bar now exists to the preliminary negotiations.

Americans End Visit to London.
London—The visit of Generals Corbin and Young to England was concluded Saturday morning, when they left Waterloo railroad station to embark on the steamer Philadelphia at Southampton. A crowd of friends was present, including Sir Thomas Lipton and others. Sir Thomas Lipton presented Mrs. Corbin with a large box of orchids.

Finances Need Replenishing.
Rome—It is rumored that the pope has determined to send special envoys over the world for the purpose of stirring up the faithful to contribute more regularly to Peter's pence. The finances of the vatican are said to be far from flourishing. The vatican has large sums invested in the Banks of Rome and the Bank of Rome and many provincial banks.

Schilling Arrives in Pretoria.
Pretoria—After having worn out 98 pairs of shoes, Schilling, the professional pedestrian, has just reached here from Bloemfontein, where he has received with great plaudits. He has still another 7000 miles to walk within twelve months. From here he goes to Cairo. Schilling says he expects to go to New York next year and travel on foot thence to San Francisco.

Rumor Emphatically Denied.
London—On the highest authority the report is denied that Princess Alice of Albany is shortly to be betrothed to the Crown Prince of Germany. When the Kaiser's first born was visiting here a year ago he was peremptorily snatched with the young and charming princess, who, being familiar with his reputation, who, being in love with every pretty girl he met, had the good sense not to regard his attentions with too much seriousness.

Sharpeners Driven From Paris.
Paris—The prefecture of police declares that he succeeded in thoroughly cleaning out a gang of English and American polished tart crooks that have made racing scandalous for the past two seasons. It is believed that Reiff may take his expulsion to the courts in an effort to overrule the Jockey club's decree. The American horsemen are shocked to learn that Reiff was not riding squarely as they believed his brother's fate was an example for him.

Famine Confronts Thousands.
London—On the threshold of a most distressful winter everything points to hard times, and if unusual cold be added to the bad industrial conditions there will be unprecedented suffering among the poor. There is an abnormal number of destitute people in the metropolis, and already the charitable organizations are taxed to present needs of the poorer classes. The board of trade statistics show the proportion of unemployed is rising fast and the general situation is worse than in years.

Carnegie's Offer Causes Dissension.
London—The action of the borough of Marylebone in rejecting Carnegie's offer of £150,000 for a public library is to be made an issue upon which election of a member of the borough council will be fought out Wednesday. The taxpayers of Marylebone are already overburdened. The council declined to accept Carnegie's offer because it entailed the total expenditure of a million dollars, only one-seventh of which Mr. Carnegie would contribute. Marylebone citizens found difficulty in holding an even balance between the duty to pay already heavy taxes and the desire to improve their neighbors' minds.

GENERAL NEWS

Passengers Injured in Collision.
Largo Crystal, Minn.—The west-bound St. Paul City passenger train on the Omaha road collided with the Des Moines passenger train at 12:21 Saturday, injuring several passengers on the latter train.

To Celebrate Washington's Initiation.
Philadelphia—Invitations have been issued for the celebration by the Grand Lodge of Pennsylvania of the sesquicentennial anniversary of the initiation of General George Washington into the Masonic fraternity, an event which took place in the lodge at Frederickburg, Va.

Grocers' Helpers on Strike.
Chicago—Members of the Wholesale Grocers' Helpers' union went on a strike Saturday to compel the Wholesale Grocers' association to live up to a wage contract adopted by the union and the grocers on September 31st. There are a thousand men in the grocers' union, and not a man is at work.

President to Be Cleveland's Guest.
Princeton, N. J.—When President Roosevelt comes here to attend the installation of Professor Woodrow Wilson as president of the University he will be the guest of President Grover Cleveland. Mr. Cleveland himself is to be a conspicuous figure in the installation ceremonies. Both he and Roosevelt are to make speeches.

Gould Securities Company Organized.
New York—The great Gould Securities company is about ready to be announced. It will be incorporated in the latter part of December or early in January. Its capital will be about \$300,000,000, in bonds, preferred stock and common stock. Missouri Pacific will be the central feature of the new corporation, and get the richest share in the prizes to be distributed.

Telegraphers Organized.
New York—The commercial telegraphers of the United States are now organizing, and their union promises to be one of the strongest in the country. Lodges have already been formed under the auspices of the International Union of Commercial Telegraphers in Chicago, Boston, Cleveland, Philadelphia, San Francisco, Portland, Ore., and at other points.

Decrease in Chinese Immigration.
Washington—The annual report of Commissioner of Immigration Sargent has been made public. Asiatic immigration shows a decrease from China of \$10, the total being 1549, and an increase from Japan of 9901, the total being 14,270, or 170 per cent. Of the entire number arriving 182,188 were unable to read or write, but 74,063 were under 14 years of age.

Trainmen Thrown in Mexican Jail.
Tucson, Ariz.—Four American trainmen have been thrown in a Mexican jail as the consequence of a wreck at Agua Prieta, which resulted in the death of five Mexican laborers. An American mob in the town of Douglas, across the international line, threatens to release the prisoners by force if the Mexican authorities do not deliver them to the American side.

Hero of Manila Bay Honored.
Philadelphia—At a meeting Saturday of the Board of Governors of the Thomas Jefferson Memorial association of the United States, held in Independence hall, Admiral Dewey was elected president. The Board consists of one member from each of the thirteen original states, the District of Columbia and the territories. The territories are represented by Hon. Mark A. Smith of Arizona.

Will Reduce Army to Peace Bais.
Washington—The war department is considering the reduction of the army. It is expected that the first reduction will be made in the hospital corps. The immediate plan will be to reduce the regiments to a peace basis. There will probably be therefore not so many acceptances for enlistment. The full strength of the army in the Philippines will probably be retained until congress meets. The probability of a reduction is based on the conditions of peace which prevail, the only war being that which the sultan of Balcad has invited.

Death Intervenes in Strange Romance.
Wichita, Kan.—A young Englishman jumped from the top of a Santa Fe freight car while crossing the Salt Fork bridge near Ponca City, Oklahoma, saying the momentum would carry him to the bank and making a bet to that effect. He fell short, however, struck a rock in the river, and was instantly killed. In his pockets were found evidences that he was a nephew of the Earl of Londale, and that he had served in the British army in India. In his pockets was a letter from London attorneys asking him to return to prosecute a claim to an inheritance.

Danish Indies Purchase.
Washington—Advice received here, while not fully confirming the report circulated in the Danish West Indies to the effect that the chances are against the acceptance by the Danish rigsdag, of the treaty of cession to the United States, make it appear that the fate of the pending treaty is really very uncertain. It is said that so narrow is the line of division between the parties in the rigsdag that the approval of the treaty practically depends upon the state of health of one or two members, and it is intimated that if the measure is to succeed at this session the government must press it to a vote before one of the convalescents is able to return to his legislative duties and cast an adverse vote.

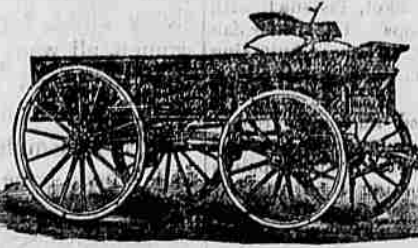
Trying to Solve Mystery.
