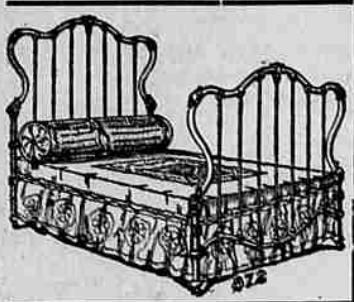

It is quite a long way in the future yet, but along about the second week in November, 1904, W. R. Hearst and W. J. Bryan can get together and compare notes as to "how it happened."

THE advantages of sticktoitiveness were never better illustrated than by the fortune of the Republican and Democratic parties. For over forty years the former has been doing business at the old stand of "Prosperity and Progress," while the latter has been switching around from "ism to ism"—free trade, silver, anything to be opposed to the Republicans. THE Government is to commence work in Oregon next spring under the general irrigation law. The preference of the majority is to be respected in this work as far as possible.

City Council Proceedings.

The following proceedings were had at the meeting of the city council on Tuesday evening:

The petition of W. S. Barnum to substitute gravel for wooden sidewalk in front of his property on North D street was denied.

Bond of E. L. Gurnea, as superintendent of water and lights, in the sum of \$2800, with H. B. Nye and E. N. Warner as sureties, was approved.

The petition of property owners on the south side of 7th street, east of Bear creek bridge, for a sidewalk was referred to the committee on streets and alleys.

The street commissioner was ordered to create no further bills against street and road fund for the next sixty days without orders from committee on streets and alleys or the mayor.

The chief of police was allowed an additional salary of \$15 per month for the remainder of his term, to take effect from December 1st.

The following judges and clerks of election for the municipal election, to take place on January 13, 1903, were appointed:

1st Ward—Judge, J. C. Ferguson; clerks, J. W. Lawton and F. M. Jordan; voting place, town hall.

2d Ward—Judge, Frank Wait; clerks, H. G. Wortman, W. L. Halley; voting place, upstairs in Hamilton block on D street.

3d Ward—Judge, A. Z. Sears; clerks, H. B. Nye, J. E. Day; voting place, Perry's warehouse.

Destructive Fire at Lakeview.

The town of Lakeview had a narrow escape from a large fire November 24th, and as it happened property to the value of \$10,000 was destroyed. At 7 o'clock a fire broke out in the Oregon Hotel and spread to the restaurant of George Jammerthal and the residence of John Avirgenett, which were also burned. Fortunately there was no wind stirring at the time, so the flames burned themselves out. The hotel property belonged to W. K. Barry, and was occupied by L. F. Winkleman. The loss on the building and furniture is figured at \$9,500 with \$4,000 insurance. The loss to Jammerthal and Avirgenett is stated at \$700.
