Kentucky School Burne and Pupils Barely Escape. Louisville, Ky., Jan. 4.—St. Cath-erine's scademy, a Catholic school for girls, located near Springhold, Ky., burned to the ground yesterday. There were no folcilities. The low is scheduled were no fatalities. The loss is about \$200,000. The fire was discovered by Miss May Curry, a cripple, and one of the sisters ran a mile in her bare feel an delad only in a night dress to give the alarm.

Between seventy-five and one hun-Between seventy-nve and one and dred girls were in the school when the fire broke out. So rapid was the progress of the flames that the pupils barely escaped with their lives, and clad only in their night robes, made their way over the icy and snow-covered fields to the academy at St. Rose, s boys' school, a mile distant, before se curing shelter." All the buildings were destroyed and the pupils lost all their

personal belongings. St. Catherine's was one of the his-toric educational institutions of Kentucky and was founded in 1804.


