The Mail is glad to see these evidences of prosperity, both for the News and for Gold Hill. The Portland marriage records the other day presented the extremes of variations of the matrimonial barometer, when a supple youth of 35 led to the altar a blushing maiden of 22; while on the same day a mature man of 19 had wedded a noble woman of 16. One cannot help thinking that a vigorous and timely application of the parental slipper might have saved lot of future unhappiness in the latter case.

A launch will soon be plying the pellucid waters of Goose Lake, the shipping receipt for it having been received, says the Lakewood Herald. Sister Smith seems to us to be a little nauy. The receipt of the shipping bill is not always proof that the goods are coming right along, especially when its press time and the consignment of paper that should have arrived several days before persists in secreting itself somewhere along the line between the shipping point and its destination.

President Roosevelt's latest scheme for the settlement of the railroad question, which he has under consideration as to the advisability of embodying it in a recommendation to congress, is one that is bound to cause a lot of comment among the people in general and if followed out considerable consternation among railroad magnates. As outlined it does not appear unreasonable or infeasible. It is nothing more or less than that the government become a small stockholder in some of the large railroads of the country, with a view to having a representative placed on each board of directors. By this process the government would become thoroughly informed as to the inside facts of every railroad and be in a position to enforce such reforms as it might desire to make. If made at all the recommendation of the president will be that the congress provide an appropriation for the purchase of a small number of shares of stock in certain railroads that may be selected. When these shares have been acquired, assuming that congress would fall in with the plan, the administration will know how to proceed to force roads into allowing a government director on each board.

The new Texas Anti-trust law that went into effect July 12, ought to be a "solus plexus" blow for the trusts in the Lone Star state, if it has the effect which its advocates claim that it will. It is by far the most drastic anti-trust measure yet enacted, and if it proves successful, its adoption by other states would result in the elimination of combinations and trusts entirely. It provides, in substance, that any person who represents an agent or sells goods made by a trust or combines, shall be deemed guilty of a felony, and, upon trial and conviction, shall be punished by confinement in the penitentiary for from two years to ten years. Its provisions apply to all merchants who sell trust-made goods and all persons who may be directly in the employ of such concerns in this state. It is announced by Attorney-General R. V. Davidson and his assistant, J. P. Lightfoot, that they intend to enforce the law to the letter. The bill was drawn by Mr. Lightfoot and his parti-

cular object was to use it as an instrument to drive every trust and unlawful combination out of Texas. Merchants do not care to run the risk of a term of imprisonment for selling such goods and many of them have already taken steps to quit handling such articles.

Cheerful Funerals.

A Baptist minister in London has announced that he favors cheerful funerals, and as an earnest of that policy he recently officiated in a suit of light gray clothes at the burial of one of the deacons of his church. "I am tired of the paganism of Christian funerals," he said. "This deacon was 82 years old, had been a good Christian all his life and died of old age, and so dressed cheerfully and we sang the Easter hymn."

This minister is sensible. When a child dies, or a person in his prime, or one's death is "untimely," as we say, expressions and emblems of grief are natural and could not be restrained; but in the case of an old person like this, to whom death was due, there is no cause for mourning. Of course an old person may be loved by his family and friends, and for a little time will be missed, but according to the universal rule of mortality it is unreasonable to mourn his demise, and often foolish affectation to put on the countenance and garb of mourning. They sang the Easter hymn. Now this was appropriate. The old man was ripe for the harvest of death; it was a natural occurrence; there should be subdued joy rather than grief because he was relieved of the burden of mortality.

The Christian on such an occasion should turn his mind to the resurrection, to the anticipated new life, to the coming spring. Christians believe that "as we have borne the image of the earthy we shall bear the image of the heavenly"; that death shall be swallowed up in victory; that the grave is but a dark portal to a better and brighter world. Then why mourn when a loved one who has been good dies? Or when an evil-doer dies, either? Death ends his sinning. We do not mean that it would be seemly to rejoice at funerals, or affect a cheerfulness we do not feel, nor that real, poignant grief should be entirely suppressed behind a mask of stolidity; but mourning belies our professed beliefs, and in the case of very old people to whom life is a heavy burden it is absurd.

Should Think Again.

The Tokio Hochi of July 7th prints an interview with Admiral Sakamoto, in which the Admiral is quoted as follows:

"Should hostilities break out between Japan and America, the result would be indecisive, owing to a want of proper bases of operations. Such bases as exist are too distant for practical purposes. Even the nearest bases, namely, the Philippines, Cavite, and Manila, are at a distance of 60 miles from one another. Even if the Washington Government should decide on a war, it is doubtful if the Americans serving in the Navy are sufficiently patriotic to fight."

"American naval officers are brilliant figures at balls and social gatherings, but they are very deficient in professional training and practice. It is too much to expect a burning patriotism in the American naval service in case of war with Japan. It is very likely that most of the crews would desert and leave the ships."

The Admiral has another guess. If he will look back over the history of the American navy he will learn that it is only in time of peace that the American Jackies desert, and the reason he does so then is because he gets so tired of doing nothing that he must look for excitement elsewhere. But as soon as war commences you could not fasten an American sailor securely enough to keep him away from his ship. If the admiral ever has the good fortune to meet American naval officers in fighting trim, they won't look so easy to him as they do at balls and parties.

Found no Satisfactory Route.

The surveying party that looked for a route for a wagon road by the way of the head of Selad creek to the Blue Ledge Copper Camp, reported unfavorably on the route on account of the high bluffs encountered on the north side on the Siskiyou mountains and the great expense necessary in putting a road through them. The party surveyed a route from the summit down Cook and Green creeks and the Middle Fork of the Applegate to the present wagon road leading to the Blue Ledge Camp from Southern Oregon, but the Supervisors rejected the survey on account of it making too long a road. A party will be sent out at once to examine other proposed routes, one by the way of the head of Horse creek, the other by the way of Garetson Springs.
