Never before in the history of Oregon or of any other state, has as valiant, forceful and winning a fight been made in behalf of education as has been waged in this state during the past few months in support of the university appropriation which was sustained Monday by an overwhelming majority.

When the movement was first inaugurated against the university, politics had much to do with the situation, but as the real status of things dawned upon the public mind and the state was receiving a black eye from abroad, while Washington, Idaho and California, as adjoining states, took advantage of Oregon's seeming disloyalty to its own to boost their own states in the eyes of newcomers, to the great disparagement of Oregon. It was then that Oregon pride and the Oregon spirit came to the front, politics was lost sight of and the people, regardless of a governor's veto and one or two knockers of the university rallied to its support, and today, with the exception of one small paper, the *Solo News*, published in a little Linn county hamlet of three or four hundred, the press is a unit in support of the appropriation, and every commercial organization of any consequence whatever, societies of whatever nature, all the prominent men in the various walks of life, have come in a most vigorous support of the institution which gives assurance that when the votes are counted in June honest but misguided men like Cyrus Walker and Eugene Palmer will see education put upon a foundation that will stand so long as Oregon stays on the map as a state in the grand old republic of America.

While this fight for educational interests has, temporarily, been detrimental to Oregon's advancement, it will prove, in the end, to have been the best thing that could possibly have happened, and when the news is spread around the world that Oregon has spoken for all time to come for the best interests of her sons and daughters the reaction will come that will make of this a greater and a grander state and of the university one of the leading educational institutions of the nation.

Already the university is feeling the effect of the great "campaign of education," as evidenced by the fact that, although the present freshman class is about 150, applications for entrance for the new year indicate that freshman attendance for 1908-9 will be almost double the present attendance.

There is a spirit abroad which says no man can be loyal to his state and to its best interests who is not loyal to its educational institutions, and that spirit was manifest in a most convincing manner at Monday's election.

Did you ever stop to consider that utter, abject poverty is almost unknown in Jackson county among people capable of earning a livelihood. There are no able-bodied men or women begging for a chance to earn a living. The charitable people of Medford have but little opportunity to bestow their bounty. At the county poor farm are a few old people who, by reason of sickness, misfortune or other causes, have come to, in their old age, charges upon the public, but that is all. This

### Anti-Saloon Parade.

Yesterday afternoon there were probably more children on the streets of Medford at one time than there has ever been before. The Sunday schools of the city paraded in the interests of prohibition and the streets were lined on either side for blocks by eager spectators. It was a sight never before seen in Medford, and it will probably be remembered long as the first time that the children of the city pleaded with the voters of the county by an immense parade in which banners stating their views on the liquor question was displayed.

There were fully 1000 children in the line of march, which was in itself of no short length. The children carried many banners with various mottoes upon them, appealing to the bystanders to vote out the saloons. Many women were in the line and a number of the business men of the city.

The parade was formed at the city park, under the direction of several men of the city, and headed by the Jacksonville band, the long line started on its march down Seventh street. The street was cleared for the paraders and was kept clear of wagons, automobiles and the like.

When the Nash Hotel was reached the line doubled several times and bunched the paraders in a crowd in front of the hotel. The band then started to play, and to the tune of "Marching Through Georgia," a parody was sung which appealed to the voters standing about to "vote the county white."

After a short program by the band near the Nash, the line was again formed and the next stop was made on Central avenue. The band played several patriotic airs and Rev. Mr. Fell rendered a solo, and was heartily applauded. Upon the completion of the solo and a few short programs by the band the line of march was again taken up and the line circled south to Eighth street. From Eighth street they marched to the Nash hotel, where the paraders disbanded, the little children being taken care of by their Sunday school teachers.

The banners carried by the paraders were numerous and were characteristic of the sentiment for which the parade stood. Several cartoons were on banners, one particularly attracting attention being a reference to the so-called Reddy amendment.

The parade was a feature that has been used extensively in the Southern states in their campaign for prohibition, and is said to be very successful.

Each of the persons in the parade wore a ribbon upon which was printed the words, "Vote out the Saloons." Leading the parade was a huge banner upon which were the words, "We follow Georgia."

The parade was conducted successfully and nothing of a serious nature occurred, which was remarkable, considering the age of some of the children who paraded. The children were all members of the Medford Sunday schools.

Muir went to the basement and after writing a confession that his accounts were short, he shot himself in the head.

He was one of the bank's most trusted employees. The shortage was about \$10,000. Muir in his confession stated that his speculations had been going on for the past five years while he was receiving teller. Three days ago he was made paying teller and was no longer able to conceal the shortage. The shortage is fully covered by a surety bond.

### HALLUCINATIONS.

Some Singular Instances of This Form of Mental Disease.

In "The Riddle of Personality" the author, H. Addington Bruce, analyzing the hypnotic treatment of hallucinations or irrational fears that often end in madness or suicide, says:

Few people are aware of the extent and variety of this form of mental disease. There is, in truth, no predicting the strange obsessions that may invade the human mind, haunting it with vampire-like insistence. One man, terrified by he knows not what, may find himself unable to cross an open space; another be afraid to venture outdoors alone; another to sit in a room with closed doors; another may feel that every one he meets is spying and criticizing him; another asserts that he is made of glass and must exercise the greatest care to prevent himself being smashed to fragments. Such fears would be ludicrous were they not so tragic.

Particularly pathetic is a case that came to Professor Janet's notice some years ago. Mme. P., a dyspeptic, had been put on a diet of toast and water and, rebelling, was wont to indulge in secret in coffee and rolls. These she found did her little harm, and gradually the habit grew upon her until finally she passed her entire time wandering from one Parisian restaurant to another, drinking from twenty to thirty cups of coffee a day and consuming incredible quantities of rolls. At night if she chanced to wake and could find no coffee and rolls in the house she would pace her room in feverish anxiety until the restaurants opened in the morning.

Somewhat similar is another case reported by the same authority:

"Here is a young woman, Que, twenty-six years of age. In coming to see us she brings with her a large bag, and her pockets are filled to overflowing. What is she bringing with her in coming to us for a consultation? It is simply provisions for the journey. She has in her bag and in her pockets several pieces of bread, a few slices of ham, some chocolate tablets and some sugar. One would say that she was going to cross a desert when it is simply a question of crossing a few streets. The provisions are indispensable to her, for, especially in the open air and in squares, it is absolutely necessary that she should take something to strengthen her. At the end of several steps she feels dizzy, becomes dizzy, chokes and is covered with cold sweats. The danger would be great if she did not know the remedy. All she needs is to strengthen herself. She eats a piece of ham, puts a piece of sugar in her mouth and is thus able to take a few more steps. But very soon it all begins again, and it is only with the aid of rolls and chocolates that she is able to cross a square. One can therefore understand her miserable plight when her provisions run short. She is obliged at all costs, with unheard of efforts, to cross the desert to reach an oasis—that is, a bakery. During this terrible journey she goes along as best she can. She may pick up a raw potato, capture an onion or a few green leaves. This hardly sustains her, but gives her enough strength to reach a bakery. In general she prefers to remain at home. That is less dangerous, and so she does nothing else but prepare and eat food all day long."

For such unfortunate there is little hope unless they place themselves under the care of the skilled psychopathologist, the savant accustomed to explore the vagaries of the mind and able to touch the hidden springs of thought and feeling and action. Then and only then will the evil spirit of obsession be exorcised and the stricken mind find itself once more in harmony with its environment.
