ORDINANCE NO. 137.

An ordinance requiring and regulating the trimming of shade trees and other foliage over the streets, alleys and other public thoroughfares of the City of Medford.

The people of the city of Medford do ordain as follows:
Section 1. It shall be the duty of the owner, or person in charge or control of any shade, or other trees, or other strubbery of any kind overhanging the streets, alleys or other public thoroughfares of the city of Medford, Oregon, forthwith to cause the same to be so trimmed as to allow passage thereunder along such streets, alleys or other thoroughfares, free from objective the surface of such street, alley or other thoroughfare.

Section 2. In the event of the fail-

Section 3. It shall be the duty of the owner or person in charge or control of any shade or other tree or other shrubbery of any kind, situate upon the streets or sidewalks of said city in front of or abutting upon any premises therein, which are used for business purposes, forthwith to cause the said trees or shrubbery are both to be entirely removed, so as to permit the mobstructed use of and businger along and across such streets and sidewalks.

Section 4. In the event of the failure of such owner or person in charge or control of such trees or shrubbery as better the taking effect of this ordinance; the said trees or shrubbery to be removed within ten days after the laking effect of this ordinance; the said well of the chief of noise and the street commissioner of said city to cause written notice to be given to such owner or person in charge or control, which tice.
