HENEY REPLIES TO SENATOR FULTON

Retells Old Charges of Alleged Corruption and Senatorial Bribery, But Does Not Give Out Much That Is New—Fulton Appointed Powell to Office.

PORTLAND, Or., April 12.—Four thousand people at the Exposition rink Saturday night listened to Francis J. Heney tell of the political record of Senator Charles W. Fulton and discuss the political tendencies of the day.

During the address the speaker brought out still more clearly the corrupt conditions prevailing in Oregon politics during the regime of the old machine and used as illustrations the bribery of Representative Homer of Jackson county, who was paid \$2500 for his vote, the attempted bribery of Representative Kruse of Clackamas county, who was offered \$2500, and then \$5000, but who refused the money and the notorious election affidavits frauds of Portland in 1904, in which Whitaker, L. Hoise, T. Ouler Powell, John P. Sharkey and others were involved.

Good Citizenship His Theme

In his address, Mr. Heney contended that his interest in making the appearance at the present time was not that of a politician, but he had no interest in who the people of Oregon selected for their representative in Congress. His interest, however, he contended, was that of good citizenship and his desire to see the people of the country cast off the shackles which were binding them closer and closer in slavery to a few interests and special corporations.

Mr. Heney exhorted the people against allowing the rule of the old machine to prevail in the state, called to mind the corruption of the past when "Jack Matthews was the official law and when the old Mitchell machine ruled the state, and warned his audience that Matthews and the old time leaders were still in the battle line of Fulton, making one more effort to regain the power wrested from them by the initiative and referendum, the direct primary law and statement No. One.

During the onslaught of Mr. Heney on the old conditions, Jack Matthews, L. J. Patterson and some other members of the old regime stood in the back of the hall paying strict attention to the address. After the relation of the 1904 election travels of Portland they left the hall.

During the course of his address Mr. Heney paid particular attention to the primary law and to statement No. 1, contending that the principle of statement No. 1 was the vital point of the whole law, which, without it, would lose its effect and bring no good to the state. He pleaded with the people not to allow the principle to be taken from them, but that they had it, contending that it furnished the remedy by which they could cure themselves of political ills in the state.

Rehearses Old Charges

Mr. Heney went over the points of his former addresses, dealing with the record of Senator Fulton, showing his connection with the defendants in the land frauds of the state and his efforts to shield these men from criminal prosecution. He brought up the fact that the senator had worked at the request of W. N. Jones, to expedite the fraudulent claims filed by Jones, and persisted in his efforts to secure favorable action on the claims and near the conviction of Jones. He contended that Fulton knew of the connection of T. Ouler Powell with the election frauds, and of his having embezzled \$6000 from Multnomah county before his appointment as United States marshal at the request of Senator Fulton.

Review of all these disclosures the speaker contended that Senator Fulton was not the right man to represent Oregon in the senate, and urged the people, if they were convinced of the truth of his representations, not to return him to office.

Senator Fred Mulloy introduced Mr. Heney and occupied a place on the platform during the course of the address.

J. P. Mulloy's new residence on South D street is nearing completion. This will be one of Medford's beautiful residences, situated in the Ross addition.

PERKINS MISTAKES DEPTH OF HARBOR

More Than Enough Water Over Columbia Bar to Admit Battleship Squadron—Invitation From Lewiston to In vite Visit from Portland Men.

PORTLAND, Or., April 13.—When Senator George C. Perkins of California, in a speech recently delivered before the United States senate, made the statement that Portland harbor afforded a depth of between 19 and 20 feet, the people of the great Columbia River basin and all those of the Pacific northwest were astonished.

The most thorough compilation of the shipping of 1907 from this port shows numerous vessels with draft ranging from 25 to 22.9 feet, and a very large number exceeding in excess of 24 feet. The people of the Columbia river basin do not appreciate the misrepresentation constantly given the river, and have asked Senator Perkins to correct his erroneous statement in the senate, but up to this time he has not done so.

Mayor Bestfield of Lewiston came to Portland on the 10th at the head of a delegation of Lewiston-Clarkston citizens, including officials of the commercial bodies, the managers of their numerous irrigation projects, railroad officials and capitalists to personally invite representative citizens of Portland to visit Lewiston-Clarkston on May 1 to celebrate the opening of the "Riparian cut-off," which means a 40-hour shortcut between these cities and Portland. "Were it not for the fact that my association makes it necessary for me to reside in the national capital," said P. J. Haskin, the famous foreign correspondent, representing some forty of the leading metropolitan papers of the country, "I would choose the Pacific northwest for my home. In no section of the world is the reward of endeavor so sure, and life so wholesome and delightful. I have encountered the most delightful weather in Portland that I have seen during a trip of more than 25,000 miles since January 1st."

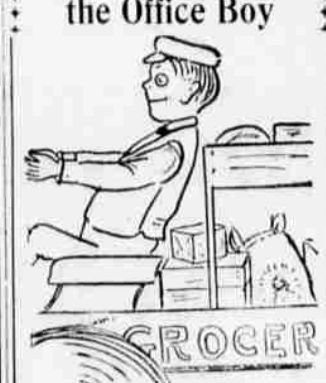
