Sealed proposals will be received at the office of the City Recorder of the City of Medford, Oregon, until June 9, 1908, at 5 o'clock p. m., for the improvement of Seventh street in said city from the east line of Laurel street to a line 100 feet east of the east line of Riverside avenue, in a manner provided by the plans and specifications on file in the office of the city recorder, subject to the charter and ordinances of the City of Medford, and the estimate of the City Engineer on file.

The above work will consist of excavating and paving street with either bituminous, asphalt or bituminous macadam, constructing concrete curbs and sidewalk, laying drain tile and constructing catchbasins.

All bids must be submitted on forms furnished by the City Recorder of the City of Medford. Each bid shall be accompanied by a certified check in favor of the City Treasurer of Medford for 5 per cent of the amount bid.
