

STOCKTON, Cal., July 30 .- After an illness of long duration, former Gov ernor James H. Budd of California died which were to run a trolley line west from Bear creek to Jacksonville, and this morning at 6:40 o'clock. The end came kquickly and pencefully. Yester-day the governor's, condition seemed day the governor's, condition seemed greatly improved. He appeared bright er and stronger than he had been at any time during the past two weeks. Late last evening, however, he suffered a relapse, and at 1 o'clock he passed into a state of unconsciousness from which he never recovered.

All night long relatives sat at the bedside. At 6:40 the nurse announced that the patient was dying. A tele phone message was sent to C. R. Harris, the family physician, but in five minutes the end had come. Uric acid poisoning resulting from the last stages of Bright's disease is given by the dor-tor as the direct cause of death.

The former governor had been a suf-ferer from kidney trouble and rheu-matism for years and had made two trips abroad in search of health. Last spring he returned from Europe

independence party. He dictated the following statement today: "The platform of the independence party contains a number of planks identical or substantially as some of the planks of the democratic platform. It demands the election of senators by a popular vote, as the democratic does. The tariff plank is on the same lines as ours. The plank relative to trusts, while opposing private monopoly, is not so specific as ours. The railroad plank does not differ from the plan in the democratic platform on the subject. The plank on Asiatic immigration is similar to the plank on that subject in the dem oeratic platform. The labor plank is also alike."

Bryan pointed out other similarities in the two platforms. In discussing what he terms the shortcomings of the independence party platform, the dem ocratic candidate said:

"The platform of the independence party does not, however, advocate the establishment of a department of labor it does not oppose imperialism and its plank with reference to the publicity of campaign funds is not nearly sestrong as ours,

"The question that much confront every member of the independence par-ty is 'will be assist in the defeat of ty is 'will be assist in the uercar on the democratic party?' which stands for so much that he favors, merely because he cannot get all that he would like?' he cannot get all that he would like?
