

ORDINANCE NO. 217.

An ordinance declaring the cost of the improvement of Oakdale avenue and assessing the property benefited thereby and declaring such assessment and directing the entry thereon in the docket of City Liens.

The city of Medford doth ordain as follows:

Section 1. That no protests having been filed against the improvement of Oakdale avenue, due notice of the intention of the council to cause said improvement to be made having been given, and said improvement having been ordered made, the council has ascertained the cost of making such improvement to be the sum of \$52,512.71.

And said council further find that the special and peculiar benefits accruing upon each lot or part thereof adjacent to said improvement and in just proportion to benefits to be the respective amounts hereinafter set opposite the number or description of each lot or part thereof, and such amounts respectively are hereby declared to be the proportionate share of each lot or part thereof of such improvement, and are hereby assessed against each lot or part thereof respectively, the name appearing above each description being the name of the owner of such lot or parcel.
