### ORDINANCE NO. 219.

An ordinance declaring the cost of the improvement of a portion of d'Anjou street and assessing the property benefited thereby and declaring such assessment and directing the entry thereof in the docket of city liens.

The city of Medford doth ordain as follows:

Section 1. That no protests having been filed against the improvement of d'Anjou street from the south line of Sixth street to north line of Eighth street, due notice of the intention of the council to cause said improvement to be made having been given, and said improvement having been ordered made, the council has considered the matter and herewith ascertains the cost of making such improvement to be the sum of \$6472.89. And said council further decided that the special and peculiar benefits accruing upon each lot or part thereof adjacent to said improvement by reason of said improvement and in just proportion to benefits to be the respective amounts hereinafter set opposite the number or description of each lot or part thereof, and such amounts respectively are hereby declared to be the proportionate share of each lot or part thereof of such improvement respectively, the name appearing above each description being the name of the owner of such lot or parcel.
