With another heavy offering of Tokays and the unfavorable weather, market was depressed, prices down 12 1/2c to 25c. Florin ears sold by us averaged \$1.21 and \$1.24. Elk Grove \$1.15. Lodi grapes sold from 85c to \$1.12 1/2 mostly. Vacaville 80c to 90c. One ear of Malagas sold by us was wrecked and in rotten condition; what were sold averaged 79c. Other ear averaged \$1.01.

Pear market strong. Half boxes Comice from Santa Clara sold today to average \$3.09. Half Forellas, \$2.30 to \$4.30. Boxes of Colorado Anjou averaged \$4.75. Car of Winter Nells from Anderson, mostly 5-tier, \$1.85.

Walla Walla prunes, \$1.20. Colorado peaches averaged 80c.
