On the second Monday in November, $185 \%$, the prevent constitn tion of Oregou was ratified by a majority vote of the electors of the territory, and the act of congress admitting Oregon into the Union was appioved February 14, 1859, on which date the constitution went in eliect. In Ses 3, Art. XIV, this constitution says: All the public iustitations of the state, hereafler provided for by the legis lative assembly, shall be located at the seat of government. In 1564 the seat of government was located at Salem for the verm of tweuty years, to remain there until by inajority vote removed. We give the above facts to prepare our readers for what is to follow in the matter of legal proceedings which are of very great importance to this eity. Last January the legislature of Oregon was in sension and mavie a number of appropriations in aid of state institutions. A mong others, for which money was appropriated, هas the bnilding and maintaining Oregow. Money was also appropriated for a branch insane asyium io Eastern Oregon, also a normal sehool, also for eularging the Re form sehool near Turner, in Marion county, also to pay teachers in the normai school bere. Shortly after junction snit was commenced by one D. T.
