

PAYING TOO MUCH FOR LIGHTS

Condor Water & Power Company Make Extra Charge to Consumers.

At the last meeting of the Board of Town Trustees an article in the Condor Water & Power company's franchise for lighting the town of Jacksonville was read with a great deal of interest, probably for the first time. An extract of the article referred to reads as follows:

" * * * * * That is to say that the town of Jacksonville shall at all times have the right to purchase said electricity at not more than 7½ cents per kilowatt hour, and said town shall not be charged more than at that rate; provided, further, that the owner or owners of this franchise shall not charge any consumer other than the town of Jacksonville any greater rate by meter measurement, or otherwise, than fifteen cents per kilowatt hour, but has the right to exact one dollar per month from each consumer when his monthly bill by meter measurement does not aggregate that amount. Said amount to be charged as rental for meters. SUCH CHARGE, HOWEVER, NOT TO BE MADE IN ANY CASE WHERE THE AMOUNT OF ELECTRICITY CONSUMED AT THE RATE CHARGED EQUALS OR EXCEEDS ONE DOLLAR FOR SAID MONTH."

So far as we have been able to learn every consumer in Jacksonville has been paying 25 cents meter rent whether one dollar's worth of electricity has been used or not; or in other words every consumer has been paying \$1.25 when the charge should be only \$1, provided, of course, that the amount of electricity used does not in the aggregate amount to over one dollar, meter measurement.

We have a bill before us now from the Condor Water & Power company wherein the consumer is charged 12½ cents per kilowatt, the total charge for the month being \$3.95, penalty 45 cents, meter rent 25 cents. It can be seen from this that the extra 25 cents for meter rent is unjust and against the franchise, and should be refunded to the consumers. Every consumer should retain his old bills from the Condor people and insist upon his rights.

The Post does not want to appear vindictive or dictatorial, but we insist that the citizens of Jacksonville be given a square deal in this matter. We offer as a suggestion that the meter rent of 25 cents, which has been illegally charged the consumers, be refunded at the next month's payments.

Perhaps this extra charge was an oversight by the Condor people, who may not have paid any particular attention to the franchise, but that does not alter the fact that the act has been committed, and the consumers demand that the wrong be speedily righted.

Jacksonville Pioneers.

Mr. and Mrs. William Russell expect to leave within a couple of weeks for Roseburg, where they go in search of a more healthful location for Mrs. Russell. They are pioneer citizens of Jackson county, it being just 45 years ago Wednesday that they were married in the Blackwell district near Gold Hill. Mr. Russell is a veteran of the Rogue River Indian wars, having been wounded six times in the conflict between the whites and red men. He was a resident of Jacksonville in 1850, when flour sold at \$50 a sack, and you had to pay \$6 for a pick or shovel.—Gold Hill News.
