It is now thought that the Pacific & Eastern will do nothing toward running their line to the coast for several months, as the failure of the Oregon Trust & Banking Co., put quite a damper on their enthusiasm.

Rumors of an electric line to run from Grants Pass to Ashland via Jacksonville is also in circulation.
