MAIL ORDER PATRON

We publish herewith a communication received last Saturday from a party who evidently patronizes the mail order house. The letter follows:

"Jackson county, Or., Nov. 21, '08. To the editor of the Jacksonville Post. Dear Sir:—You ask why the people allow themselves to be hoodwinked by the mail order houses of Chicago. Take one of these catalogues and look it over, and then ask the price of some of the articles of any merchant in town and be convinced. You say the merchant pays about 50 cents for freight, and the 'hoodwinked' pays \$3.00, if this is so, why do the merchants tack on the extra \$3.00 freight? 'Here is the point of contact, I have taken some notice myself. Why do these merchants buy spices from Boston and sell them for the same price they do those put up in Portland? Why does the Chicago bunceos sell shoes for \$1.50 less than the manufacturers do in Napa, California? Why does the local merchant buy from agencies like Marshall-Wells & Co.? or the Denver company instead of from the manufacturer and pay freight three or four times on the goods before they are delivered?"

"The merchants themselves are to blame. Let them compete like they do in the east for business instead of combining and holding prices up out of reach. There is a change of no small note taking place in the west. '49 prices are still in many places. When a man comes from the east and asks the prices of goods, what is the result? He sends back for an eastern catalogue, because he has been used to getting his supplies about 75% cheaper and of a grade the same as is sold here. I could tell you some of the prices we used to pay, and the reason they are so much higher here. Who gets the profit of Oregon spuds sold in San Francisco? Why do most of the western producers ship their crops to some over-stocked markets, and take less than they can get at home and pay freight besides? Some of the merchants must add several times the 50 cents per 100 freight to raise cheese from 9 cents up to 22½ cents per pound."

"It is mostly because they all want all the money they can get."

AN EASTERNER.

This is mail order catalogue argument. You can see it on every page of this monster catalogue, and evidently the catalogue house has this party by the back of the neck. If you get one of these catalogues and read it—read the flimsy arguments they put forth—eventually you will develop a hatred for your townspeople, as this party has done, it will not fail.

He asks some questions which we will have to dissolve: "Why do the merchants buy spices from Boston and sell them for the same price they do those put up in Portland?" We know of no such spices being sold in this city as Boston spices, but nevertheless should this be the case, we will say that the spices were grown probably in the same field and why should we not be willing to pay the same price for goods which we know are not adulterated and where a man is paid good wages under sanitary conditions and keep our money at home?"

"Why do the Chicago bunceos sell shoes for \$1.50 less than the manufacturers do in Napa, California?" The California "Oak Block" sole leather is the finest and best leather in the world and therefore must be more expensive to produce. This leather costs more to manufacture than a great many catalogue shoes are worth. Your catalogue house does not handle one brand of standard made shoes. You can get shoes for 75 cents and \$1.00 a pair but I only hope that our merchants will never cheapen their stock with such goods."

"Why does the local merchant buy from agencies like Marshall-Wells & Co.?" Because Marshall-Wells & Co. is the largest manufacturing hardware company in the world. Having large factories in England, France, Germany South America and three in the United States. They manufacture goods on the ground where the best materials are produced, thereby eliminating the excess freight on rough and raw material. Many catalogue houses buy second and third grade goods from these large manufacturing concerns at greatly reduced prices and sell them out over the country under different brands.

Now brother it is only fair to ask you to do something. If you notice that your catalogue quotes very few standard grade goods you will do well to look up the following: The "Christy" bread knife set is a stunkard article. See whether your catalogue quotes this article at 35 cents. The postage on this set is 10 cents which means that you will pay 69 cents for this set delivered from your catalogue.

About the cheese you specify no particular brand and we will say in this case that cheese made of skimmed milk is very cheap, about nine or ten cents muskinned cheese sells for about 15 cents and pure cream cheese sells for about 20 cents, the market price changes on cheese and if you will notice your mail order house sends out monthly price lists on groceries and other articles.

A few democratic papers in the state are making considerable noise about the next United States senator. The people want a man in the United States senate who will have some influence with the administration. We must have legislation favorable to the west and with a democrat in the senate from this state what show would we have to secure this legislation. KEEP TO THE RIGHT

"Keep to the right" is law of the road, which, when obeyed, saves one a world of trouble.

Society is a public highway on a grand scale—a great turnpike whereon a hurrying, jostling, wrestling crowd of badly-assorted humanity is ever thronging. Here is life in all its better phases—childhood with its golden hair and wondering eyes youth with its widening, thoughtful outlook; manhood with its firm step and earnest purpose; old age with its bowed form and whitened locks. Here, too, are thickly strewn the wrecks of life—misguided childhood, headstrong and wayward; erring youth, rioting in frivolity and dissipation, and sowing the seeds of physical decay and moral death; vicious manhood, treading the downward road; and decrepit old age, sinister and sere, with its painful memories and hopeless future—all commingling in the one great journey from the cradle to the grave.

How much discord, inharmonious, and jostling would be avoided in this journey if each traveler would only keep to the right. There is a pitfall before you young man; a temptation to do evil; a snare for your feet. You are forming habits of idleness, dissipation and extravagance, which will stick to you like the shirt of Nessus hampering your noble efforts, and eventually dragging you down to the gateway of despair. Keep to the right and avoid it.

That is a doubtful business venture, sir, in which you are about to engage; one perhaps involving loss of self respect and sacrifice of manly principle. You see where, by taking advantage of your neighbor's ignorance, you can be the best of him in a trade; or by some smart trick of the law you can evade some responsibility you have willingly assumed, or shirk some duty that lies in your way. Keep to the right. There, only, is the path of honor.

When tempted to deal in gossip or scandal; to play the tyrant in your family; to withhold the gentle word of love or praise from her who walks by your side; to lower the standard of your honor, or do ought that would make you less manly or noble in the eyes of good men and angles,—keep to the right.

Keep to the right. These golden words should be engraven in letters of living light on the temple of every human soul. They should stand forth as finger posts at the junction of every wrong; at the point of every divergence from the straight path of rectitude; by every wayside temptation.
