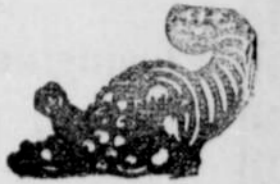




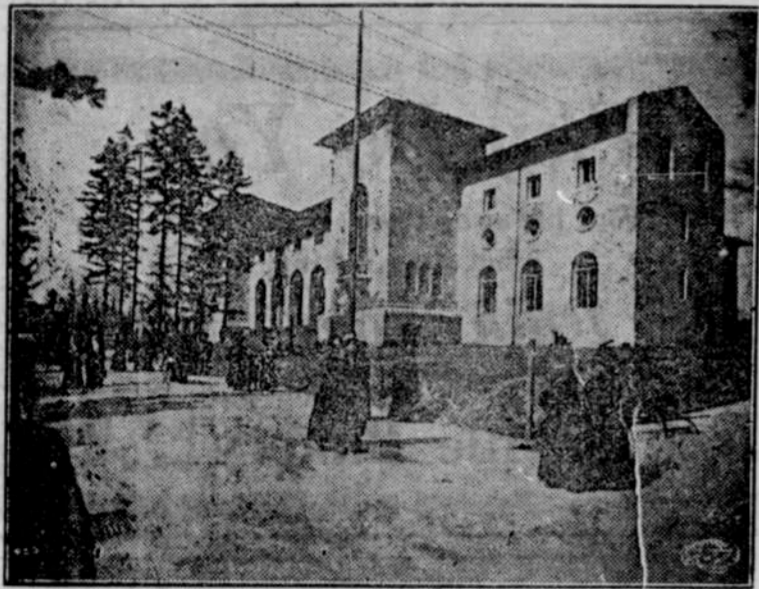

THE CALIFORNIA BUILDING AT A.-Y.-P. EXPOSITION, SEATTLE.

## More Ten-Acre Tracts

The Wilmer Realty Company composed of capitalists of Wilmer, Minn., who recently bought the A. A. Porter farm of 600 acres on Grave Creek, are plating 400 acres of the property and will soon begin the sale of 10-acre tracts. The cutting up of this place, which is one of the choicest spots in Oregon, will mean much for Josephine County, as it will bring to this section 30 to 40 families who will each depend upon their 10 acres for a living and this will secure the highest cultivation. The whole tract is bottom land with plenty of water and we may expect it to be covered with the choicest of fruit in the near future. W. J. Pinney, one of the owners, is interested in 23 grain elevators in the middle west but is intending to dispose of his holdings and make Grants Pass his home. This will take some time, but he has instructed A. H. Carson, who is attending to his business at this end, to buy for him the best house in the city which is for sale.—Courier.

## KILLED ON RAILROAD

### L. M. Colby Struck by Train Near Medford.

A man named Lorenzo M. Colby was struck by a Southern Pacific train, while attempting to cross the track about two miles south of Medford, Monday evening.

The buggy in which Mr. Colby was riding was completely demolished and the occupant hurled a considerable distance receiving injuries from the effects of which he died about half past nine o'clock, the same evening.

Mr. Colby was 22 years of age, a native of Jefferson, Iowa and was married to a daughter of H. M. Coss of Medford.

## General News.

A mob stormed the county jail and shot to death Tom Barnett, a convicted murderer, at Abeline, Texas, Friday.

Three thousand men employed in the Homestead Steel works at Pittsburg, Pa. received full pay envelopes, Friday being the first full pay in 18 months.

The Baldwin Locomotive works at Philadelphia, received an order from the Harriman lines for 105 locomotives last week. This is the largest order received since 1907.

Ortis Hamilton was formally arraigned in the superior court at Olympia, Wash. on the charge of embezzlement of state funds, Tuesday morning. This is only one of his alleged offences, several other charges are pending.

The A. P. Y. Exposition was formally opened at Seattle, Tuesday afternoon.

Four masked robbers held up and robbed a party of thirty in a public house near Denver, Col. Monday.

The jury in the Hanley case, tried in the Federal Court at Portland has found the defendant guilty of "maintaining illegal fence." This constitutes a misdemeanor, punishment for which is a fine not to exceed \$1000, or imprisonment not to exceed two years.

The Mayor of Centralia, Wash. has issued an order forbidding "confetti battles" during a carnival to be held in that city.

Mrs. George Shea of Duluth, Minn. who is visiting her sister at Seattle, Wash. was robbed of \$20,000, in currency Monday night. The money had been concealed in the bed clothes and was taken during the temporary absence of the occupants of the house.

E. H. Harriman and wife sailed for Bremen Tuesday. It is their intention to spend a vacation of three months abroad.

Employees of the box factory, sash and door plant and saw mills, at McCloud, Calif., have gone out on a strike, demanding an increase of 25 cents per day.

The Washington State Grange is in session at Ellensburg.

Mary Able, a 13-year-old school girl, was drowned in the Coos river near Marshfield Saturday.

Work on the Coos Bay, Oregon and Idaho railroad was begun Tuesday. A party of surveyors consisting of 20 men started on the survey near Marshfield.

## City Council Meets

### Election Set for June 24--- Franchise Given Telephone Company --- Usual Number of Bills Allowed.

The regular meeting of the city council was held at city hall Tuesday evening, present: Messrs. Britt, Davis, Dunford, Fick and Shaw; Recorder Dox.

Minutes of previous meetings read and approved. Committee reported the erection of gate at the cemetery. The usual grist of bills were presented and after some discussion were allowed.

The amended ordinance granting a franchise to The Pacific Telegraph and Telephone Co. was read, discussed at some length and being placed on final reading the ayes and noes were called, resulting in the passage of ordinance as read.

The matter of improvement of the Applegate road was discussed, the sentiment being in favor of immediate improvement.

The publisher of The Post reported that part of the new charter was in type but that the balance of the copy had not yet been received from the attorney and publication could not be made until next week. On motion the date for special election was set for Thursday, June 24.

## Shaft for Founder of G. A. R.

Washington, May 31.—Work has begun on the concrete foundation for the shaft memorial to the Grand Army of the Republic and to Gen. Stephenson, the founder of that magnificent organization, which is to be formally dedicated with appropriate ceremonies in the beginning of September next. This memorial is to be erected in the attractive circle on the east side of seventh street, exactly at the junction of Louisiana avenue and C street. The work is being done by direction of Col. Cosby, engineer officer in charge of public buildings and grounds. Congress appropriated \$10,000 for the foundation including the pedestal. The memorial was designed by J. Massey Rhind, the New York sculptor. It is in the form of a tall triangular shaft of gray granite, with bronze reliefs on the sides, representing, respectively, "Fraternalism," "Charity" and "Loyalty," the principles of the order. The monument entire, exclusive of the pedestal will cost about \$35,000. The money was raised by the Grand Army of the Republic, mostly from members of the order. It is intended to present the memorial "to the people of the United States." The site and design of the memorial were selected by a commission appointed by act of congress providing for the erection of the memorial.

## Government Timber.

Figures of government timber sales on the national forests in Oregon and Washington given out yesterday by the Portland office of the forest service show strikingly that confidence in the lumber business is fully restored and that an era of increased activity is at hand. Since timber purchased in national forests must be cut immediately, contracts running from one to five years, these transactions indicate the actual state of business more accurately than private stumpage sales, which are often only speculative.

Applications are now being examined and sale seems almost assured for 3,000,000 feet. Of this, about 3,000,000 feet is in Alaska, 250,000,000 in Oregon and 127,000,000 in Washington. Stumpage prices offered range from \$1 a thousand in Alaska to from \$2 to \$3 in Oregon and Washington. It is expected that this increased demand will continue and that the year 1909 will show a total of national timber sale business in the Pacific northwest many times larger than that of even the best 12-month periods during the lumbering boom of three or four years ago. This is of interest to the general public because a quarter of the receipts from national forests go to the road and school funds of the counties in which they are situated.
