STATE ROAD LOSES.

Crater Lake Road Knocked Out. Attorney Mc Mahan wins suit in the Circuit Court at Salem.

L. H. McMahan has won his case in the circuit court at Salem, having obtained the order asked for restraining the expenditure by the state of the \$100,000, appropriated by the last legislature for the construction of a state highway to Crater lake. Judge Gallo-way rendered a decision in the case Tuesday morning in which he holds that the law appropriating the money was purely local, as it applied only to two counties, and special because it is limited to a specified section and for a special purpose.

It is the intention of the attorneys for the state officials to have the case carried to the supreme court, hoping to get a reversal of the decision.

Oregon Settler of '51 Dies

Benjamin Mensch, one of the Oregon settlers of 1851, died at Grants Pass Monday. He was born at Wilkes-barre, Penn., January 2, 1830, came west and was a scout in the government service in Northern California in the Indian troubles of the 50's. He settled at Grants Pass about 1863. He was the pioneer brickmaker of the Rogue River Valley. He leaves a wife, Mrs. M. J. Mensch, and one son, Fred Mensch, the present county surveyor of Josephine county.

IRRIGATION PROJECT

Propose to Irrigate 30,000 Acres in Yakima Valley

Representatives of 10 cities and many districts of the Yakima Valley assembled last week at Sunnyside to organize to promote the high line canal to irrigate lands above the Selah, the Moxee canal near North Yakima, the Union Gap irrigation company's canal near Parker and Rillah and the Sunnyside canal from Parker to Kiona.

It was decided to appoint a committee of 30, three from each of the towns affected, to meet the irrigation committee of the United States senate on its tour of the irrigation projects next fall. Over 300,000 acres are involved under the proposed canal project.

It is proposed to start the canal at Cle Elum from the Yakima river. From there the canal would go south and east through the Yakima valley, terminating near Kiona. This would mean about 90 miles of construction work. The state of Washington took up the proposition some 18 years ago and expended \$17,000 on surveys and the project was shown to be entirely feasible. It was dropped by the state owing to lack of funds. With the United States reclamation projects now under way and the lands embraced in these two projects over 1,600,000 acres will be reclaimed in Benton, Yakima, Kittitas and Klickitat counties, the major portion being in Benton and Yakima counties.

State Fire Law

An act passed in 1907 to provide for the protection against forest fires and to create a state board of forestry made it unlawful during the months from June 1 to October 1 for any person to set fire to any slashing, chopping, wood land or brush land, without permission from a state fire warden and compliance with the terms specified.

A Step in Advance

In the matter of curtailing human liberties and tramping upon personal liberties, Oregon with its liquor law, its hat-pin law and its nine-foot sheet law, has a close second in Washington, where is just going in to effect a law forbidding the smoking of cigarettes, and a statute requiring a certificate of good health from both parties in a proposed marriage. We shall watch the effect—or the fate—of both laws with interest, for both stand for a advancement. There are nine chances out of ten that in a test case they will either be found unconstitutional or a technical loop-hole will be found by which their provisions may be avoided. We hope it will be otherwise, especially for the sake of the marriage law.

The hour struck some time ago for 20th century civilization to wake up and take notice of the fact that not only a principle of social economy but the welfare of the whole body of society is concerned in the matter of matrimony—so often entered upon hastily and lightly, and so often repented of before the divorce courts with an accompaniment of shameful publicity.

The marriage law, like all similar attempts and propositions that have gone before it, will meet with derision and criticism as interfering with inherent human rights and an intrusion

into sacred precincts that should be beyond the reach of man-made laws. This is one of the most expensive notions the human race ever indulged, and it has been indulged some centuries too long. When it comes to discussing human liberties and things sacred, the fact should be considered that there is nothing so solemnly sacred as the liberties and the happiness of the race as a whole. The subservience of individual liberty and indulgence to the demands of the society as a whole, is one of the triumphs of modern civilization. In fact there is no law that makes for the general good that does not restrain the individual.

From many there will come the cry that such a law is in advance of the age. Just so. There never was a beneficent law nor the enunciation of an uplifting principle that was not in advance of the age which gave it birth, even from the day when Jehovah thundered from Sinai. It is because of these advanced principles that the race has advanced.

If the people on Mars ever get into touch with this mundane sphere, their first gasp of astonishment will be at the discovery of the fact that for centuries we have been breeding improved onions, roses, poultry, pigs, dogs and horses, and have reached the highest degree of perfection in many of these lines, but in the matter of our offspring we have been "letting nature take its course."—Outlook.
