### Suberb of Medford

If plans now under way do not miscarry, Jacksonville is destined to become a suburb of Medford and have her surrounding hills dotted with the residences of people who will have their places of business in Medford and their homes in the immediate vicinity of the county seat. A syndicate of wealthy eastern people have been looking over the valley recently and have worked out plans whereby such a system will become feasible. The plans of the syndicate, which for the time being is keeping its personnel hidden, include the macadamizing of the road to Jacksonville along its entire length and the placing in operation of a monster automobile, constructed on the plan of an English coach, with upper and lower decks for passengers. This motorcoach will make regular trips and the fare will be moderate. The company plans to arrange matters with county officials so that walnut trees will be planted along the road which, when they bear will pay for the keeping up of the road.

The hills about Jacksonville are ideal as building sites. The plan is splendid and will do much to build up the valley. With such a service the development of the valley between Jacksonville and Medford would be rapid and would rapidly be covered with homes. The motor car service on the Jacksonville road will also aid in the furthering of the plans. —Medford Tribune.

## Council Meeting

### Adjourned Meeting of City Council Held Tuesday Evening--Returns of Special Election Canvassed--Bonding Proposition Carried by a Large Majority--Bids for Tunnel Opened, Etc.

The City Council met in adjourned session Tuesday evening.

Present--Councilmen **Britt**, **Davis**, **Dunford** and **Shaw**, Recorder **Dox**, Attorney **Newbury**. Absent--**Pick**.

A couple of small bills were presented and on motion were allowed. A communication, asking for an appropriation for the Soldier's and Sailor's Re-union to be held Sept. 13-18 was laid over until next meeting.

The returns of the special election to authorize the issuance of bonds for the construction of a system of waterworks, were opened and canvassed, showing that a total of 102 votes had been polled, of which ninety-one were for the bonds and eleven were against the bonds. Mayor **Shaw** issued a proclamation, as provided for in the charter, declaring that the bonding proposition had received a majority of all the votes cast for or against it and that Ordinance No. 125 is made part of the city laws.

The bids called for by the council for excavating tunnels at the city well were opened and read. There being only one bid, that of **M. Hege**, presented, action was deferred for the present.

The question of street lights was discussed in an informal manner, also the matter of safeguarding the electric light wires, some parties claiming that insulation of wires were insufficient; that in case a stream of water from a hose was thrown on a wire the holder of the hose would be in danger of electrocution. The recorder was instructed to correspond with the Light & Power Co. and report at next meeting. Council adjourned.

### TO GET A NEW TRIAL

Supreme Court orders new trial for **Walworths**--Have already served two years

The following in regard to the **Walworth** case is taken from Wednesday's Telegram.

The Supreme Court reversed the decree of Judge **H. K. Hanna**, of the Circuit Court for Jackson County, and ordered a new trial for **Charles H. and Norval Walworth**, father and son, who have already served two years of a life sentence in the penitentiary for the killing of **James F. Mankin** during a double duel, the culmination of a long standing family feud. The opinion is written by Justice **McBride**.

This bloody four-handed shooting affair was precipitated because **Charles H. Walworth**, who was working in the field with his son **Norval**, noticed the approach of **Carroll Mankin**, who was carrying a cane, and mistook the cane for a gun. With the remark, "It's a gun you want," the elder **Walworth** rushed excitedly to the house, procured a rifle, and despite the warnings of his son, who tried to tell him of his mistake, fired a shot in the air. **Henry Mankin** was already on the scene, and a sister **Belle Mankin**, brought a shotgun and a rifle from the **Mankin** home, **James F. Mankin** having joined his brothers in the meantime, and gave the arms to **James F. and Henry Mankin**. The **Mankins** then opened fire and wounded the elder **Walworth**, who had ceased hostilities, whereupon **Norval Walworth** appeared at the corner of the house and engaged in a duel with **James Mankin**. They fired simultaneously, and **Walworth's** shot killed **Mankin**, and **Walworth** was wounded in the face. Meanwhile **Henry Mankin** went around the house, found the elder **Walworth** lying wounded with buckshot, and shot him in the head. **Henry Mankin** was also wounded in the arm.

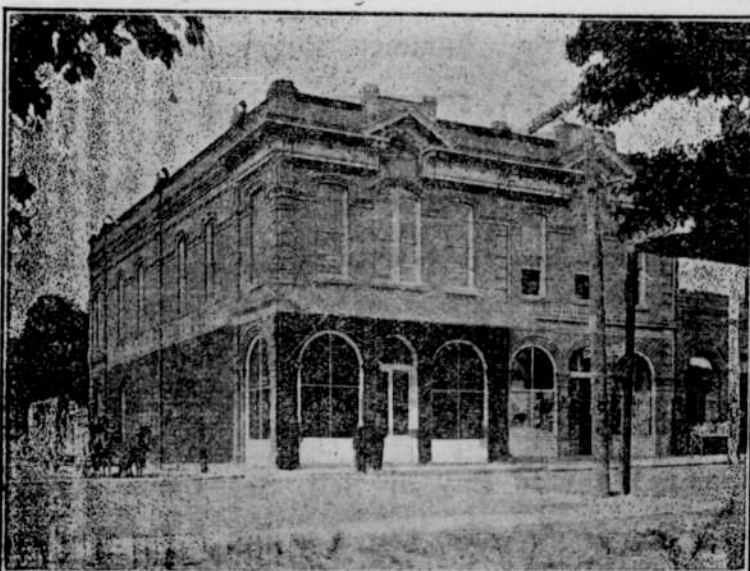
