FRANCHISE TURNED DOWN

By a small majority in Ashland—Light vote, only 428 votes cast.

By a vote of 228 to 200 Ashland turned down the application of John R. Allen for a trolley line franchise in that city, Saturday. Only a light vote was polled, about one-half the usual vote of the city.

The result of the election was a surprise to many persons in the valley, who thought the citizens of Ashland more progressive and enterprising, but it seems the mossbacks and knockers were slightly in the majority.

It is to be hoped that Mr. Allen and his associates may see their way clear to build the trolley line without the franchise in Ashland, and not allow the shortsightedness and grasping proclivities of the men who defeated its passage, to ruin or retard the prosperity of the whole valley.

At the same election, a franchise was granted to J. R. Anderson for a franchise for a gas plant which will doubtless be operated in competition with the municipal lighting plant.

RUN OUT JAPS

Citizens of a Washington town drive out 30 Japanese laborers.

Darrington, Wash., June 14.—Sunday there were 30 Japanese in Darrington. Today there is not one in or near the town.

A mob of 100 white men yesterday marched on the Japanese, practically all of whom were employed by the United States Lumber company, gave them an hour to gather up their effects, and then accompanied them to the station, and saw them aboard a Seattle train.

The Japanese arrived here three weeks ago from Seattle, the first large party of orientals ever brought into town. Saturday night a mass meeting was held, and yesterday's action was planned. The Japanese offered no resistance and there was little disorder.

Darrington is a town of 400 people, in the extreme northern part of Snohomish county, about 40 miles back from the sound, the terminus of a Northern Pacific branch line.

NEW RECORD

Set by Hamilton—Flies from New York to Philadelphia without a stop.

Monday morning Charles K. Hamilton the aviator, set a new record for long sustained flight, remaining in the air one hour and fifty minutes and covering a distance of 86 miles.

Hamilton left New York at 7:38 A. M. and arrived at Philadelphia at 9:28 A. M. making the entire distance without stop.

The flight was made under the auspices of the New York Times, and the Philadelphia Ledger, who it is said contributed a purse of \$10,000. for the daring aviator.

Council Meeting.

An adjourned meeting of the city council was held in City Hall, Wednesday evening. Present: Mayor Shaw; Councilmen Fick, Dunford, and Grieves; Recorder Dox.

The cement sidewalk ordinance was presented and after considerable discussion was passed first reading.

The matter of a new election for voting water bonds at 6 per cent interest, was discussed at length and an ordinance providing for same was introduced and passed its first reading.

On motion of Mr. Grieves, seconded by Fick, it was ordered that the recorder prepare and have printed notices, requiring all persons to clean up streets and alleys in front of, or alongside their residences or property, and that marshal serve such notices upon the owners or tenants of said premises. Adjourned.

HILL GETS CONTROL OF PACIFIC & EASTERN.

Hill interests have completed acquisition of the Pacific & Eastern Railway by purchasing the remaining 40 per cent of stock, which was held by J. R. Allen, former president of the company. With this purchase, a new official personnel has been named, with John F. Stevens president, William Gerig vice-president and manager, and J. W. Lawler secretary. The directors of the company are: J. F. Stevens, J.

R. Allen, C. E. S. Wood, S. B. Linthicum and William Gerig. The Hill people are said to have held 60 per cent of the P. & E. stock prior to this latest purchase, and now have absolute control, for the working out of whatever plans they may have in respect to the future of the P. & E. Completing the present work of about 22 miles, and extending surveys toward the East, are the only plans divulged by the new control. But the people of that region believe that the Cascades are to be crossed at this point, and are expectant of an announcement to this effect in the near future. It is apparent that all of the Willamette Valley and Northwestern Oregon are to be reached by Hill lines, through such systems of the Oregon Electric and United Railways.

DIES NEAR HIS CABIN

J. H. Hart, aged resident of Trail creek found dead. Coroner investigates.

J. H. Hart, who is well known throughout Jackson county, was found dead at his home on Trail creek 20 miles above Eagle Point Friday afternoon. Owing to certain circumstances surrounding the location of the body when found, the coroner was summoned and went up Saturday to conduct an inquest.

The body was found by neighbors at a considerable distance from the house in which he lived. It was lying by the side of the creek and on one side of the head was a deep bruise which may have been the cause of death. However, the theory advanced was that the aged man had died suddenly of heart failure.

Mr. Hart is the father-in-law of Dee Bradshaw and is one of the old time residents of Jackson county.

TIMBER SALE

In Douglas County by United States Government.

Roseburg, Or., June 14.—With the United States as the seller and the Fir Lumber Company, composed of Eastern capitalists as the buyer, an immense deal in timber lands is being closed at Cottage Grove today. The lumber company buys 175,000,000 feet of Douglas fir and hemlock for \$350,000, a rate of \$2 per thousand. S. C. Bartrum, of this city, supervisor of the Umpqua National Forest, acts as sales man for the Government. The timber lies on Row River 20 miles east of Cottage Grove. The buyers will immediately erect at or near Cottage Grove a sawmill of 100,000 feet daily capacity.
