The Bond Plan.

The proposed initiative measure to empower counties to issue bonds for road purposes ought to pass. Those to whom the petitions are presented for signature should not hesitate to sign. It is an entirely proper measure to be offered the electorate, and one that is almost certain to be adopted.

The measure itself does not issue bonds. No bonds could be issued until after a vote authorizing it in the county in which such vote is taken. It is merely a plan to clothe each county with authority to use the bonding plan for improving the roads of that county if, after mature consideration, the people of that county shall, by popular vote, determine to do so.

A road is an asset of economic and social life. A farmer cannot do good farming with a broken plow or a worn out binder. He cannot haul grain to market satisfactorily or economically with a team of cayuse ponies, or on a wagon with half the spokes out of one wheel. Nor can he economically or satisfactorily transport his products to the buyer or railroad station over a cayuse road. The attempt to do so is costly, wasteful and helps to cause failure. The cayuse road costs the farmers of the country \$300,000,000, and the farmers of Oregon \$2,000,000 every year. It is an awful toll on human endeavor, and that is why the plan has been evolved for authorizing any Oregon county to issue bonds as an aid in good road building. It is unthinkable that the measure can meet with serious opposition.—Journal.
