THE NEW SIDEWALKS

If property owners neglect to construct sidewalks they will be built by the city council.

The order for the construction of the cement sidewalks was made under and accordance with the provisions of the city charter, and as there seems to be some misunderstanding in regard to same, an explanation of some of the provisions may be in order.

Section 126 of the charter, makes it the duty of all owners of land adjoining any street, alley, or other thoroughfare in the City of Jacksonville, to construct, re-construct and maintain in good order a sidewalk or sidewalks in front of said lands.

Section 127 authorizes the city council whenever it deems proper, necessary, expedient, or convenient, to order, and upon proper notice, to require owners of such lands to build said sidewalks.

Sections 128, 129, 130, and 131, prescribe what shall be included in said order and notice, and the manner of serving the same and require that proof of service be made in the manner specified.

The two succeeding sections we give in full:

"Section 132. If the owner, occupant or agent of any such land or part thereof shall fail, neglect, or refuse to fully comply with said order within the time designated, the council shall immediately proceed to make or cause to be made, under the supervision of the city surveyor and street commissioner, all the repairs and construct all the sidewalks and every other matter or thing required in said order which the owner, agent or occupant of said property has failed, refused, or neglected to do.

Section 133. The officers under whose supervision said sidewalks are constructed or repaired or otherwise improved shall keep an accurate account of the cost of labor and materials in making the repairs or constructing the sidewalk or otherwise improving the same in front of each lot, parcel of land or part thereof and upon the completion of such repair, construction, or improvement, such officer or officers shall file an itemized statement of the cost of labor and material required in constructing, repairing or otherwise improving the sidewalk in front of each lot, part thereof or parcel of land, together with the name of the

owner, agent or occupant. Such report shall be verified by such officer or officers, filed with the recorder and by such officer submitted to the council. Upon the approval of this report by the council, either as submitted or as corrected or amended, the same shall be entered by the recorder in the docket of city liens, and shall be collected in the same manner as are liens for improvements."

APPLE SHOW

To be held in Portland Nov- 30 to Dec. 2.

Oregon's apple show will be held in Portland November 30 to December 2. It will be a great exposition of the state's fruit-growing possibilities and it will be of wide interest because of Oregon's fame as the home of the red apple. There promises to be exhibits entered in competition for prizes from every apple-growing county in the state. The Corvallis Commercial Club has already offered \$100 for the best apple exhibits from Benton County and the Hood River Commercial Club has offered \$50 for prizes for the best apples shown from that section. Other counties will yet be heard from in the same way.

ANOTHER PIONEER GONE

Funeral of Mrs. Barbara Newbury held Saturday afternoon.

The funeral of Mrs. Barbara F. Newbury was held from her late residence in this place, at two o'clock Saturday afternoon and was attended by a large number of friends and acquaintances.

The services were conducted by Rev. Robert Ennis of the Presbyterian church, after which the body was laid to rest in the beautiful Jacksonville cemetery.

Mrs. Newbury was an old and respected citizen of this place who had passed more than the "four score" limit, being at her death aged 83 years and 12 days. She had been a resident of Jackson county for many years having come here from Pennsylvania.

She leaves one son, Gus Newbury of Medford, and two daughters, Mrs. Mary Peter of this city, and Mrs. Hattie Moore of Baker City, and a number of grandchildren to mourn the loss of a kind and loving mother.

WAKING UP

Sidewalks--Improvements at the court house--additions to residences.

The staid old city of Jacksonville has shown more signs of awakening in the way of improvements, during the last ten days than in the twelve preceding months. The sound of the workmen is heard on every hand. The old stone walks on the main streets of the town are being torn out and replaced with new cement walks; the county officials have sunk a well and erected a steel tower for water tank in the court house yard and have a large force of workmen engaged upon the construction of a long needed sewer system for the court house and jail.

LAI D TO REST

Judge Hanna's funeral held Wednesday by Red Men--Tribute by W. M. Colvig.

The funeral of Judge Hanna was held from his late residence in this city Wednesday afternoon and was attended by a large concourse of friends and acquaintances from the entire valley.

The funeral was in charge of the Improved Order of Red Men, of which the deceased was a prominent member. The members of the order in full regalia marched at the head of the procession to the cemetery where the beautiful ceremonies of the order were observed.

A large number of the attorneys of both Jackson and Josephine counties were present, mutely testifying to the high regard in which the illustrious and venerable jurist was held by his brothers of the legal profession.

W. M. Colvig, Esq. of Medford, at the request of the members of the Bar present, in a few well chosen words referred to the life and actions of the deceased as those of a man governed by the principles of "Eternal Right and Justice," one who stood on every occasion for what he believed to be right and truth, regardless of all personal advantages to himself. The speaker very feelingly referred to the assistance which the deceased had rendered in many instances to students of law and young practitioners; that he had always been ready and willing to help those desiring to advance.

He testified to the high feeling of esteem and reverence entertained by the members of the bar for the deceased, and that his death was an irreparable loss to the profession which he had so honored during his life.

The ceremonies at the grave closed with the liberation of a dove, symbolizing a messenger of truth to the spirit land.

WENT FISHING

But failed to return to the State prison

A news dispatch sent out from Salem, Tuesday says: Penitentiary officials allowed John Dohl, a Lane county convict, to go fishing Sunday, and he has not yet returned. Dohl was about 63 years old, was thought to have been slightly demented and may have lost himself. At any rate he has not yet come back. He was just completing a 20-year term for criminal assault, and during the past five years, on account of the weakened state of his mind, had been allowed many liberties, one of which was the privilege of fishing in Mill creek, which flows through and near the penitentiary walls. Sunday afternoon Dohl wanted to go fishing, and when closing time arrived investigation showed he had wandered away. He had been worrying much lately, according to Superintendent James, about his heart, and this may also have helped to disturb his weakened mind. His term would have expired in a year or two.

GRANTS FRANCHISE

By a vote of 285 to 64, Ashland grants franchise to John R. Allen.

At the special election held in Ashland, Saturday, the citizens of that burg granted to John R. Allen a franchise for an electric trolley line in that city. The vote being 285 in favor of the measure and 64 against it.

The result of the election reverses a vote taken on a similar proposition several weeks ago and removes a formidable obstruction to the construction of the electric line in the valley.

It is expected that work will be begun on the line this fall although no definite promises to that effect have been made. Right of way should be given freely and everything done to assure the construction of the road and installation of service at an early day. It is a fact recognized everywhere that electric railways are the greatest factors known in modern times for the development and up-building of the section through which they pass and are deserving of encouragement and assistance by every proper means.

The people of Ashland are waking up to the needs of the hour and are to be commended for the action taken at the election Saturday.

CHECK IS NOT CASH

Says Supreme Court of Oregon--Decision important to merchants.

Salem, Oregon, July 26.—Holding that property in a thing does not pass when a check is the price paid in a sale of personal property and the check is dishonored upon presentation at a bank, the supreme court today affirmed the case of Charles F. Johnson, doing business as the Portland Gun & Bicycle company, respondent, vs. Sam Iankovetz, doing business as the Maine Loan office, appellant. The case was tried before Judge J. B. Cleland in the circuit court for Multnomah county and the opinion affirming the lower court was written by Justice Ea'm. Iankovetz bought a gun of Johnson and gave a check in payment. The court held that this was not a sale until Johnson had received the cash; that it is presumed sales are for cash, and when cash is not forthcoming, the sale fails and property does not pass.

JUDGE HANNA DIED MONDAY

Venerable jurist and pioneer of Oregon dies in this city Monday afternoon.

Hon. Hiero Kennedy Hanna, one of the best known and most highly respected citizens of Jackson county, passed away at his home in this city at 3 o'clock Monday afternoon.

The venerable jurist had been in failing health for some time, having resigned from the bench partly on that account in February of this year, but his condition was not considered serious until about four weeks ago, since which time he had been confined to the house under the care of his physicians.

The funeral was held from his late residence Wednesday evening, under the auspices of Oregonian Pocahontas Tribe No. 1. Improved Order of Red Men, of which the deceased had been esteemed member for many years.

Judge Hanna was born in Bath, New York, May 22, 1832, and at the time of his death had lived considerably past the allotted time of "three score and ten", being in fact a few months more than 78 years of age. He came to Oregon many years ago, was in fact one of the first settlers in this region.

The greater part of his life has been spent in this city and in a public capacity. It can be truly said of him that "He served his country long and well," doing his duty faithfully and fearlessly as he saw it. During his occupancy of the bench (he was Judge of the Circuit Court for 25 years) his decisions and rulings have been eminently fair and impartial, unbiassed by any considerations of personal likings, enmity, or private gain, and his fame as a jurist engrafted upon the records of this district and state, and in the hearts of his fellow man will live and remain a lasting monument to his memory long after his body has mouldered to dust.

In private life the Judge was quiet and of unassuming manner, genial and courteous to all, and to those intimately acquainted was a pleasant and interesting friend and companion; one whom it was a pleasure to know.

By his death, his wife and family loses its protector and head—a kind and affectionate husband and father; the legal profession loses one of its ablest members, one who for more than a quarter of a century has been a shining light in the courts of Southern Oregon; and the community an honorable, upright, and respected citizen and an honest man.
