

California Oil.

Oil operators throughout California are watching with a great deal of interest the boring of well No. 2 of the Maricopa "36" Oil Company, which is nearing completion within 300 feet of the world-renowned Lakeview gusher. Many experts predict that with the tapping of the dense stratum of gusher sands that have made the Lakeview the greatest producer in the history of the world, another tremendous spouter will be brought in.

The well now is down 1955 feet with eight-inch casing, and the work of cementing off the water is under way and it is expected that the well will be finished within two weeks.

The breaking forth of the Lakeview, March 15 last, forced the suspension of drilling operations on this well, the oily combustible from the Lakeview deluging the drillers and causing them to flee to safety. Work was suspended for several months, because of the danger from fire.

As another precautionary measure the Maricopa "36" Company is building a large reservoir on its property, which in itself is a natural reservoir, and will use every means to keep the well under control.

The finishing a few months ago of No. 1 well of the Maricopa "36" Oil Company, which is situated 1200 feet from the Lakeview, created quite a stir in oil circles, for the well gave every promise of being another Lakeview. The well was completed at 1888 feet, and for several days intermittently shot oil over the derrick, finally sanding up. The sand was cleared away and the well produced from 300 and 400 barrels of 20 1/2 gravity oil per day, when free from sand, but as the gas pressure is great considerable difficulty is experienced in keeping the hole clear. As only 75 feet of oil sand was penetrated in this well, the management intends to deepen the well when No. 2 comes in.

It is a gross abuse of the rights guaranteed by the Initiative Referendum Amendment to the Oregon Constitution to bring up woman suffrage at every general election. This measure was submitted in 1900 and beaten by a plurality of 2137. In 1906 it was again proposed and was beaten by 10173. In 1908 it was again on the ballot and was beaten by a majority of 21649. Notwithstanding these repeated defeats, more decisive at each election, the same measure is again on the ballot this year. The ballot title is misleading and indicates a proposal to give votes to taxpaying women only, but the measure to be voted on is the same proposition which the people have so often and so recently condemned. It should be voted down this year by an increased majority, especially because of the fraud undertaken to

be perpetrated on the people by the use of a false and misleading title on the ballot.
