Among the measures approved by the people at the recent election is the amendment to the constitution, Expenses..... changing terms of judges, etc. and providing that in civil cases three-fourths of the jury may render a verdict. "Section 5. In civil cases three-fourths of the jury Time certificates of deposit. 2,271.66 may render a verdict. No person shall be charged in any circuit court with the commission of any crime or misdemeanor defined or made punishable by any of the laws of this State, except upon indictment found by a grand jury; provided, however, that any district attorney may file an amended indictment whenever an indictment has, by a ruling of the court, been held to be defective in form.'
