GREEK MEETS GREEK

Trial of George Bouzos for Killing of Christ Spanos.

The trial of George Bouzos, accused of murder in the first degree for the killing of Christ Spanos in a Greek pool room at Medford, on the evening of August 16, 1911, was commenced in the circuit court in this city Monday morning when the selection of a jury was begun.

The prosecution is conducted by District Attorney Mulkey and Judge Colvig of Medford, and the defendant is represented by Judge Kelly of Medford and Robert G. Smith of Grants Pass, the attorneys on both sides being specially noted for their skill in handling criminal cases it is a case of "When Greek meets Greek," in a two-fold sense.

Monday and until three o'clock Tuesday was spent in selecting a jury, the examination being very rigid at least in regard to two points—self defense, and capital punishment, the defendant's counsel objecting to those jurors who did not favor the law of self defense, and the prosecution being careful that no juror had conscientious scruples against the infliction of the death penalty in proper cases. After the jurors were passed "for cause" the peremptory challenges were taken, the state waiving its right several times but the defendant exercising the right twelve times, the full number allowed by the statute.

The following are the names of the jurors composing the panel, viz: G. W. McNabb, Ira Dunlap, R. O. Duncan, H. A. Barney, Fred Herrin, Marion Tryer, J. W. Bonar, J. E. Ensley, E. A. Ford, S. C. Newhall, W. C. Deneff and Jasten Hartman. After the jury was selected and sworn the prosecution made a short statement, outlining the acts charged as having been committed by the defendant. This was followed by a brief address by Mr. Smith from which it appeared that the defense would consist mainly of the doctrine of "self defense." The taking of testimony was then begun, three witnesses having been called and examined when a recess was taken until Wednesday morning.

Wednesday morning the jury was taken to Medford and allowed to view the room in which the shooting occurred, in order that the testimony of the witnesses would be more readily understood.

The testimony of the witnesses was vague and sometimes unsatisfactory owing to the fact that most of the witnesses do not speak English and an interpreter had to be used. There was considerable conflict between the evidence offered by the state and that presented by the defense, chiefly in regard to who was the aggressor in the affray.

The taking of testimony was continued Wednesday and all day Thursday with the exception of a short time Thursday afternoon when a recess was declared owing to the illness of one of the jurors, and was concluded Friday forenoon.

The address of counsel for the prosecution were able and eloquent, covering the principal points brought out in the course of the trial. The charge of the court in submitting the case to the jury was fair and impartial; briefly stating the law of self-defense, rules for determining the credibility of witnesses, the definition of what constitutes a reasonable doubt, explanation of the different degrees of homicide, etc.

The case was submitted at 2:50 o'clock, and the jury after being out about 16 hours returned a verdict of guilty of manslaughter.
