OLD NEWSPAPER

Now in Possession of W. H. Johnson, Daily Sun, Printed September 3, 1833

William H. Johnson of this city is the possessor of an interesting relic in the newspaper line, a copy of the New York Sun, dated September 3, 1833, being a little more than seventy-eight years old. It contains four pages of three columns each, set in nonpareil type leaded, carries considerable advertising for the size of the sheet and some news, mostly of the police court and accounts of shipping. Its number is 1 but the volume number is not given. The prospectus on the first page announces that "The object of this paper is to lay before the public, at a price within the means of everyone, all the news of the day, and at the same time afford an advantageous medium for advertising. The sheet will be enlarged as soon as the increase of advertisements requires it—the price remaining the same."

City Fathers Meet in Special Session Tuesday Evening.

A special session of the city council was held in the City Hall, Tuesday evening pursuant to the call of the mayor.

JUDGING SHEEP FOR WOOL

College Experts Give Advice—How to Tell Good Fleece.

Oregon Agricultural College, Corvallis, Ore. Oct. 24.—To judge sheep for wool production, one should remember in the first place that the long wool breed show coarser fiber than those of short wool, "says Mr. George R. Samson of the animal husbandry department of the Oregon Agricultural College.

"This coarseness should not be allowed to become extreme. The fleece should be thick and clean; the fibers should be strong, bright and free from dark or diseased spots. In the medium wools a thicker fleece is desirable—thickness sufficient to turn rain. The fibers, as in the long wools, should be relatively long, clean, lustrous and contain an abundance of grease.

"To examine a fleece, the portion just over the heart is noted to discover the finest wool, and that on the leg for the coarsest. There should be as little difference in the fleece on these parts as possible. To open the fleece, place both hands, palm down, on the fleece and, shoving down slightly, pull the hands apart. This breaks the fleece without tearing. If the fleece is heavy it breaks on a smoother line than if light, when the fibers are quite likely to be intertangled."

PORTLAND LETTER

Club Discusses Benefits of Trips. Butter makers to Meet December 6 to 8.

Portland, Or., Oct. 24. (Special)—A step of permanent constructive benefits was taken last Saturday night at the Portland Commercial Club when business men gathered at a dinner to discuss the benefits of recent excursions to Klamath Falls, Central Oregon and Aberdeen, Was. The big dining room was filled by men of affairs and the experiences given and the policy outlined for future excursions were of great value.

The meeting developed into a symposium on the attitude of Portland business men to outside territory in the two states and was a survey of conditions existing from Aberdeen to Klamath and in Central Oregon. The result will be a closer tie between Portland and the outlying country and this promises to be of great aid in future development.

Redmond will hold a potato show on November 2. This is the date the O. W. R. & N. demonstration train arrives at Redmond and the two events will undoubtedly bring a very large number of farmers from the surrounding country to Redmond. At the same time a meeting of dairymen will be held to organize an association.

The joint line of the Oregon Trunk and the Deschutes Railroad will be opened to passenger and freight traffic to Bend from the Columbia River on November 1. The new lines are now operating to Opal City.

An apple tree near Albany has been sold for \$300. It is everbearing, maturing fruit at all seasons of the growing period, with buds, blossoms and apples on tree at the same time. A nursery company has bought the tree and will try to establish a new everbearing variety.

Dairymen and butter and cheese makers will gather in Portland December 6, 7 and 8 for the annual convention and special plans are under way to make this year's gathering the largest and most interesting ever held. Experts from the East will be in attendance to judge the different exhibits, of which there will be many, and well known authorities on various topics of interest will deliver addresses. There will be more and better prizes offered than ever before.

The program has just been made up for the first annual convention of the Oregon State Hotel Men's Association, which will be held in the convention hall of the Portland Commercial Club on December 5 and 6. The hotel men will discuss matters of mutual interest and seek ways to increase tourist travel to this state from California and the East.

Eugene will hold its biggest apple show on November 3 and 4, the coming exhibit throwing all previous shows far in the shade. The annual fruit exhibition growing all the time in importance because of increasing orchard acreage around Eugene, and this year the festival will take on more than local interest. Prizes have been offered that make it an object for fruit growers to compete.

Lakeview will add agriculture to its high school courses as soon as its new building is finished. This is a new and important feature of the course of study and one that progressive communities are adopting.

THREATEN WAR

Lynching of Black May Bring on Race Strife in Southern city

Coweta, Okla., Oct. 24.—Virtual martial law prevails here today following a lynching and threatened onslaught from the negro element. National guardsmen are patrolling the streets and more troops are expected during the day. It is estimated that the negroes can muster a fighting force of 2000 men, and there is every indication that a serious race war will begin here today.

City Attorney J. D. Beavers was killed and Harman Oliver and Stellar Thomas wounded, while City Marshal Hart was attempting to disarm a trouble making negro, Ed. Suddeth. In the ensuing melee the negro was overcame and later lynched and two other negroes were shot.

The trouble began on Saturday when the right of way on a sidewalk was disputed by Suddeth and a white man and woman. Suddeth pushed the woman into a pool by the sidewalk. A group of white men quickly overpowered and punished him, and he was abroad with a knife yesterday, bent on vengeance.

FUNERAL OF MRS. KENNEY

Held Sunday Afternoon at her Late Residence.

The funeral of Mrs. Elizabeth T. Vault Kenney of this city who died Friday, was held Sunday afternoon at one o'clock.

Services at the late residence of the deceased were conducted by Rev. Hedges, pastor of the Presbyterian church of this city. The singing by the choir was specially fine, the selections being rendered with an expression and in a manner equal to that of the best choirs in our large cities.

After the services at the house, the cortege slowly wended its way to the cemetery on the hill, overlooking the home where the deceased had lived so long, and the beautiful valley which she had loved so well.

HEARST'S JUDGMENT

As to Good Democratic Candidates for the Presidency.

Mr. Hearst is a Democrat, and he cannot be expected to sorrow as those who are without hope over the prospect of Democratic victory. There are good Democratic candidates, and he specifies two of them, whose names might suffice to lead the party to victory. These two, it might naturally be supposed, are Woodrow Wilson, of New Jersey, and Judson Harmon, of Ohio. Guess again! Harmon is a second edition of Parker, and therefore impossible, while Wilson is clever but doesn't know where he is at half

of the time. There are not the kind of men the Democratic party wants to lead it to victory. Those that loom up largest in the Hearst horoscope are Champ Clark, of Missouri, and Oscar Underwood, of Alabama. With such standard bearers as these, Mr. Hearst thinks, the Democratic party might advance to assured victory.

SAYS SON IS INNOCENT

Colonel Richeson Says he Will Give all Available Funds to Help Son.

Amherst, Va., Oct. 23.—"If he is proved guilty, which is impossible, I had rather be dead than face the world as his father," declared Colonel T. V. Richeson, father of Rev. Clarence V. T. Richeson, of Cambridge, Mass., accused of the murder of Miss Avis Linnell, his former fiancée.

Colonel Richeson, who resides near here on his farm, comprising hundreds of acres, declares that all his available funds will be used in his son's defense, if necessary.

"I know my son is innocent," said the father, "and I shall defend him in every way possible. When the time comes I will go to Boston to be at Clarence's side. I am not rich, but I can give him financial aid."

NEW RECORD MADE

Great Northern Makes an Average of 40.1 Miler an Hour on Trip.

St. Paul, Oct. 25.—All running records between Seattle and New York were smashed by the \$1,000,000 silk train which passed through St. Paul early Sunday morning. Advances received at the Great Northern general offices are that the train arrived in New York at 5:35 P. M. Monday the 17th, making the coast-to-coast journey in 81 hours and 50 minutes.

The best time made by a silk train, starting over the Great Northern, previously, was 102 hours and 5 minutes, a year ago. The Chicago, Milwaukee & St. Paul last winter made the run in 97 hours and 40 minutes.

The record of the silk train beats that made by the fast mail of the Great Northern, which makes the journey from St. Paul to Seattle in 48 hours. The actual running time from Seattle, made by the silk train of five cars, was 45 hours and 16 minutes. It left Seattle at 3:45 o'clock Friday morning, arriving in St. Paul at 4:01 Sunday morning.
