HAWKER WAS ECCENTRIC.

An English Poet and Clergyman Who Married His Godmother.

Robert Steven Hawker, poet and vicar of Norwinstow, England, was an eccentric person. In his younger days he used to dabble the village physician's horse with stripes of paint until the animal looked like a zebra and then summon the physician hastily to an urgent case miles away in the country. Two elderly women whom he disliked he is said to have driven out of the town by sending all the undertakers in Plymouth to measure them for their coffins.

His marriage, too, was out of the ordinary. It happened while he was at Oxford. His father told him that he could not afford to keep him there any longer. Hawker at once set out to the home of his godmother, Miss Charlotte Fans, twenty-one years his senior and the possessor of an annuity of \$1,000. He is said to have "run from Stratton to Bude, arriving hot and blown," and proposed to her. She accepted him. He returned to Oxford a married man and won a fellowship. The marriage was a happy one.

When his wife died Hawker wore at her funeral a plunk hat without a brim. But this was in no disrespect to her memory. It so happened that it was his usual headgear at that time.

Getting Evidence.

Keeping the Hands Smooth.
