THE PROPOSED ASSESSMENT

In this issue appears the notice of proposed assessments for construction of the distributing system in District No. 1. The total cost of pipes, hydrants, valves, fittings, excavation and backfilling is divided among the property within the district as set out in the resolution adopted last winter. In making this proposed assessment the fronting and area of the property were mainly considered but in a few instances reductions were made on account of the physical character of the property—the charter provisions being to the effect that assessments be made in proportion to the special and peculiar benefits.

Considerable difficulty was experienced in getting proper descriptions of the various lots, parts of lots and parcels of land; many lots have been sub-divided so as to make smaller tracts of every conceivable size and shape, many of which have never been properly surveyed and the descriptions in the deed records in numerous instances are vague and indefinite, entirely inadequate to enable one to locate the property intended to be conveyed.

The assessment, with the exception noted above will average about \$75.52 for each 100 x 100 feet lot, or \$37.76 for 50 x 100 ft. and are uniform throughout the district. In addition to the publication of the notice referred to, a notice has been mailed to each owner whose name and address is known.
