**BANK ROBBER CAUGHT**  
**Ten Days Flight of Ray Diamond ends at Gold Beach. Most of Money Recovered.**

Gold Beach, Ore., June 26.—Staggering out in the open trail near here at noon today Ray Diamond, the young man who robbed the Glendale State Bank of nearly \$3000 last week, was arrested by the sheriff here. He made no resistance, declaring he was exhausted and could no longer stand the hardships of the mountains. "I intended to give myself up several days ago," Diamond declared, "but was afraid to come in while the search was hot." Almost all the money taken from Assistant Cashier Smith was found on Diamond. The rest, it is thought, is hidden somewhere on the trail. It was a meek desperado indeed who stood handcuffed in the little lockup here. All his bravado was gone and he appeared to be thoroughly worn out by his ten day flight through the timber. Diamond, who is about 22 years old, walked into the Glendale State Bank a week ago last Monday, engaged Assistant Cashier R. C. Smith in conversation and then pointed a rifle at him, ordering him to throw up his hands. Diamond then helped himself to the money which Smith had just taken from the safe to begin the day's business. Pleeing with the booty, Diamond exchanged shots with Smith, none of the bullets taking effect. Sheriff Quine at once started on the trail, but without the bloodhounds when he found Diamond had fled into the mountains and was probably making his way toward this place.

**MAP ENGRAVERS SCARCE.**

**United States Geological Survey Would Like To Get Some.**

No finer maps are made than the engraved topographic atlas sheets of the United States Geological Survey. In accuracy of detail as well as in quality of printing the Survey asserts, with little fear of contradiction, that its maps lead all others, wherever printed. Great advances have been made in recent years in various phases of the printing art, but for fine mapwork, strange as it may seem no process has yet been found equal to the original hand engraving, which is still essentially the same process that it was generations ago. The skilled copperplate engraver who cuts on his metal base the thin lines which produce the map is as necessary now as he was during the middle of the last century. Not everyone can be a successful engraver. It requires a fine touch and a good eye. An announcement recently made by the Civil Service Commission indicates that the profession of copperplate engraver is by no means overrun. The Geological Survey wants competent map engravers at salaries ranging from \$3 a day when actually employed to \$1,600 a year and is having difficulty in finding applicants to compete for the positions. No regular examination is required, but samples of work, properly authenticated, must be submitted. The Chief Engraver of the Survey at Washington will be glad to hear of anyone who wants such a job and who can measure up to high standard of engraving work required.
