### The Week

While business generally reflects the quietness usual at this period commercial tendencies are mainly in the direction of improvement and confidence in the future has strengthened. Financial sentiment vis a vis effect of what by the failures in the Pittsburgh district, the resumption of gold exports and the threatened railway strike yet security values were all maintained in view of these developments. A new low record price, however was reached on United States bonds and also on British consols, the markets abroad being depressed early by fears of complications in the Balkan situation. Included among the important events of the week was the Government grain report, which, while showing a large deterioration in spring wheat, revealed a splendid promise for winter wheat and corn, thus indicating another prosperous year for the agricultural community as a whole. This augurs well for the business outlook, but the spirit of conservatism is still manifest in most quarters, owing chiefly to the restrictive influence of tariff legislation. On the other hand, evidence of expansion are not wholly lacking, although conditions seldom show any important change at midsummer. The marked improvement in the leather situation, however, furnishes an exception to this rule, the more liberal demand from large operators having advanced prices on all varieties.

Dry hide hemlock sole is now higher than at any other former time this year, while in some other lines the values current several weeks ago have been restored. Consumption of dry goods is sustained and there is no accumulation of stock, but few business is limited to well-defined needs. In the iron and steel industry two features stand out prominently—name y, the fact that consumption of pig iron output during June was less than anticipated and that the opinion is general that the current lull in demand will be followed by a revival of activity in the fall. As expected, the regular monthly statement of the leading interest disclosed another substantial reduction in unfilled tonnage, yet the volume of orders remaining on hand is still above the average.—Dun's Review.

## PORTLAND LETTER

### Scouting Party To Invade Central Oregon.

Portland, Ore., July 15 (Special).—In order to arouse interest in the meeting of the Oregon Development League to be held August 19-21 at Klamath Falls and to personally carry a cordial and urgent invitation to the business men and ranchers to attend that convention, a party representing the Portland Commercial Club, the railroads and the newspapers is now making an automobile tour of Central Oregon and will devote all of this week and next to a series of meetings for the purpose of securing delegates to O. D. L. gathering.

The party left Portland last Sunday for Bend, the latter being the real starting point of the tour, being preceded by a letter addressed to every commercial organization in the territory to be covered giving the itinerary in detail. This advance notice will enable each community to make preparations for a large attendance at the meetings to be held on arrival of the party. It is hoped that the excursion will result in securing information which will enable the Oregon Agricultural College and the Portland Commercial Club to help Central Oregon in the development of its resources.

The cannery of the Fruit Growers' Association, at Eugene, is running to full capacity and 24 quarts of loganberries or raspberries are being turned out for every minute of the working day. Due to increased acreage and unusually favorable weather conditions the berry crop in the Eugene district is unusually large this year.

Writing from La Grande, H. C. Maris, a field worker of the Oregon Agricultural College, states that the citizens of the different sections of Union County are co-operating in an effort to make their county fair a record breaker in every respect this year. They propose to get together an exhibit at La Grande, October 8-11, that will convince their own citizens, as well as all visitors, that Union is second to no other county in the state in agricultural production. Industrial, agricultural and horticultural exhibits staged by the children of the county will be made a prominent feature of the fair.

In order to protect the seeds of Douglas Fir that will be planted during this summer, a campaign of extermination will be waged against field mice and other rodents in the burned over sections of Tillamook County, and poisoned grain will be liberally scattered over a tract of about 2,000 acres to be reforested. As soon as the poison crew finishes its work; a force of men will be sent to do the seeding, a task which will require three months. In addition to the 2,000 acres to be seeded, an additional 1,000 acres will be planted with young trees.

Visitors to the world's fair at San Francisco in 1915 will be reminded by the Southern Pacific that Oregon is "one of the sights you can't afford to miss." As a result of a series of conferences recently held between the officials of that line, the "Shasta Route," the line between Portland and Sacramento, will be widely exploited. Crater Lake, the great fruit orchards of Southern Oregon, the Willmetts Valley, the grand scenery of the Cascades and the varied industries of Western Oregon will be made the subjects of pictures and stories to induce tourists to include a trip through Oregon in their expedition plans.
