



Old Abe, the Eagle That Went to War

The accompanying picture shows Old Abe as he looked when stuffed and mounted in the Wisconsin state capitol before his destruction by fire on Feb. 24, 1904. The history of the eagle which accompanied the Eighth Wisconsin to war is well known. He was a living standard, nobler than any effigy in bronze or gold ever borne above the legions of Rome or among the victorious eagles of Napoleon. It was fitting that he should pass away in flames even as the stormy years of his youth had been lived in the fierce fray that challenges death amid the dre and smoke of battle.

ORANGE JACOBS DEAD
Pioneer of Oregon and Washington, Jurist, Editor and Congressman.
 Judge Orange Jacobs, pioneer of Oregon and Washington, died suddenly in Seattle, aged 87 years. He was born in Geneseo, Livingston county, New York, May 2, 1827, and on the occasion of his eighty-seventh birthday celebrated only a few days ago, he was in his usual state of health. In 1831 his parents removed to Michigan, where he grew to manhood. He crossed the plains in 1852, settling first in Marion county, Or. Five years later he went to Jackson county, where he became editor and publisher of the Jacksonville Sentinel, meanwhile practicing law. He was appointed associate justice of the supreme court of the territory of Washington in 1867 and the following year was made chief justice. He had lived continuously in Seattle since 1869.
 Judge Jacobs was elected to Congress from Washington territory on the republican ticket in 1876, serving four years.

FORGIVE AND FORGET
Douglas County Couple Settle Differences, All Parties Leave Together.
 Ben Kennedy and Mrs. R. J. Norris of Camas Prairie, Douglas county, arrested Friday night at Ashland by the sheriff's office upon complaint of the husband, affected a reconciliation with Norris Saturday, and all left for San Francisco Sunday. Mrs. Norris said she wanted to visit a sister in California, the husband would not permit, so she departed with Kennedy. All three maintain that nothing not within prescribed circles occurred on the elopement, so-called. The husband's wrath subsided when he saw his wife in jail, and he took steps to annul any action of the law. He also paid all expenses.
