MEN WANTED

State Officials in Kansas, Missouri and Oklahoma Send Out Call for Aid.

Washington, June 2.—Kansas, Missouri and Oklahoma raisers of wheat need at least 82,000 more men to help in harvesting their crops, and the Commissioners of Labor of those states have asked Secretary of Labor Wilson to have his department co-operate with them in obtaining the necessary workers. The men will be wanted by June 15, and the pay it is stated will range from \$2 to \$3.50 a day. The period of employment will be from three to five or six months.
