Jacksonville School Boys Defeat Talent School Team to Tune of 16 to 12.

Terriific Gale at Newport

Newport, Or., Dec. 22—The storm which set in Sunday evening raged furiously until late Tuesday afternoon. It is estimated that the wind velocity was 65 to 70 miles an hour. The rainfall during that period was 4.32 inches, but the damage done here was slight—a few washouts on the streets and a drifting snow driven through the Olsonville tramway. Beach travel was suspended during the storm. Along the Yaquina river, the high tide overflowed and washed out considerable diking, and telephone wires throughout the county are prostrated. The schooner Mirene escaped the storm by being barbound at Alsea.

Two Arrests by Game Wardens

Game Wardens E. I. Walker and Lon Applegate arrested W. A. Garrett and C. G. Garrett of Ruch, on the divide between Griffin creek and the Little Applegate Monday charged with killing venison out of season.
